# THE ANNIVERSARY FESTIVAL OF THE R.M.I. FOR GIRLS.

THE second, in order of occurrence, of the Anniversary Festivals of our Masonic Institutions for the current year has now passed into the domain of history, and, as might have been anticipated from the fact of the chair having been occupied by His Royal Highness the Duke of Connaught, the result is a brilliant success. We must not be understood as for one moment suggesting that the Craft is more mindful of its duties, and of the absolute necessity it is under of supporting our Charities, when a Brother Prince of the Blood Royal presides on one of these occasions. Yet, the brethren would be churlish indeed if they did not make a point of seconding the efforts of a Royal Craftsman whenever, in the multifarious duties that devolve upon him in his exalted position, he finds opportunity for doing what, were he less overwhelmed by business cares, he would of a certainty be only too happy to do frequently. It is not surprising, therefore, though it cannot of course be less a matter of congratulation, that we should now be in a position to announce, as worthy Bro. Hedges announced on Wednesday evening, that the total amount of subscriptions on the occasion of the Ninetyfourth Anniversary of the Royal Masonic Institution for Girls was in excess of £13,200. We have so considerably extended the operations of our three Institutions, the number of beneficiaries for whom provision must be made is now so greatly in excess of what it was only half a dozen years since, that if sums proportionately in excess of what were formerly needed are not forthcoming, it will be a matter of duty on the part of the executive of each Charity to curtail the number of those who are benefited. This would be so great a calamity that we feel sure the Craft, while there is a possibility and probability of the means being forthcoming, will never dream of sanctioning a reduction of its charitable labours. It is, therefore, with a heart that is light, yet at the same time not unduly sensible of the greatly-increased responsibilities that have been recently undertaken, that we congratulate the Duke of Connaught, the Girls' School, and the Craft, on the great success which attended the meeting on Wednesday.

The Masonic Girls' School is, indeed, an Institution which is worthy of the support of all kindly-disposed persons, be they Masons or non-Masons. The charge of providing a liberal, yet appropriate education, for the female children of deceased or indigent persons, to whom all other opportunities or means of education are unhappily denied, is one that necessarily commends itself to all. But in Masonry, one of whose guiding stars is Charity, this is essentially the case. We are very far from claiming for the Craft a monopoly, or even a superiority over other sections of the community, of this divinest of virtues. Still, the teachings of Freemasonry, to say nothing of its natural bent, is Charity, and if we do not find it in its midst, where, we ask, can we hope to find it? Love of one's neighbour is the prime motive power of its being, and what becomes of that love, if it does not make suitable provision for the aged and the orphan, who are unable to provide for themselves.

One noteworthy feature in connection with the proceedings we record this week deserves especial mention. In One of his speeches, the Duke of Connaught announced Board of Stewards; Bro. John A. Rucker, President of

that he had the Queen's permission to state that Her Majesty had been graciously pleased to become Chief Patroness of the Royal Masonic Institution for Girls. Such an announcement might well have been anticipated, seeing that the Queen is not only the mother of Masons, but the daughter of one of the noblest and kindliest of the Craft—Grand Master the Duke of Kent; yet is it none the less a gracious and considerate act on Her Majesty's part, that she should have consented to become the Chief Patroness of "Our Girls."

Wednesday's celebration was, as usual, preceded on Monday by the public distribution of prizes, with the accustomed recitations and musical display. This took place under the genial presidency of Lord Leigh, Provincial Grand Master of Warwickshire. Everything passed off capitally, and among the pupils who distinguished themselves were not a few who had obtained more than one reward of merit. For example, Emma Lizzie Bridgeman, to whom was awarded the Gold Medal given annually by Bro. W. Paas for Proficiency, with Bro. Winn's supplementary £5, took a prize for passing in honours the Cambridge Examination, Bro. Faulkner's prize for Physical Geography, and one of the "John Boyd Memorial" prizes for Drawing. Charlotte Coleman, in addition to the Silver Medal for Good Conduct, with Bro. Winn's £5, received prizes for passing the Cambridge Examination with honours, and for religious knowledge. To Susan Jane Norrish were adjudged Bro. Winn's £5 for Proficiency, a prize for passing in honours Cambridge Examination, and one for Perseverance, Class II. Edith Ann Wilson, Gold Medallist of last year, was given a prize for passing the Senior Cambridge Examination, and Bro. Dr. Brette's Prize for French. Ada Huyshe Clase received prizes for passing Cambridge Examination and Elocution; Sarah Lissie Bellamy for Music, Cookery, and Freehand Drawing; Alice Georgiana Pike for Writing and Drawing and Elocution; Annie E. Scott for Needle Work and Good Conduct—the latter given by the Supreme Council, 33rd Degree.

It is time, however, we came to the main event of the year, as associated with the Girls' School. The Duke of Connaught, who presided, had previously taken the chair at one of the Boys' School Festivals, and his advocacy was attended with a marked degree of success, albeit the year in which he so presided was not a fortunate one. On this occasion, however, he has fared magnificently, and may take unto himself the satisfaction of having been a principal means in conveying into the coffers of the Royal Masonic Institution for Girls the exceedingly handsome sum of £13,232, with the product, whatever it may be, of fourteen yet outstanding lists. Indeed, we shall not be much out of our reckoning if we se down the result as approximating very closely to, in round figures, £13,500, if it does not exceed that sum. The Board of Stewards which supported His Royal Highness the President of the day was a formidable one, numbering, as it did, some 340 brothren, more or less. Among the most conspicuous of these supporters who were actually present may be mentioned Lord Leigh, Prov. G.M. Warwickshire; Lord Suffield, Prov G.M. Norfolk; Sir Francis Burdett, Bart., Prov. G.M. Middlesex; General Brownrigg, C.B., Prov. G.M. Surrey; Sir Henry Edwards, Bart., Prov. G.M. West Yorkshire; Sir J. B. Monckton, President of the Board of General Purposes, and acting President of the

sentees.

the Colonial Board; Rev. C J. Martyn, Dep. Prov. G.M. Suffolk; Captain John Wordsworth, P.G.J.W. West Yorkshire, &c. &c. The sister Institutions were represented by their respective Secretaries, Bros. F. Binckes P.G.S., and James Terry Prov. G.S.W. Norths and Hunts. The dinner was, as is invariably the case, in the very best style of Freemasons' Tavern, and the requisite attendance on the needs of the guests, both ladies and brethren, was carefully superintended by Bro. A. Best, and his right hand man Bro. Dawkins. The musical arrangements, which had been entrusted to Miss Marian Burton, gave every satisfaction.

As to the actual proceedings of the Festival we need say nothing further here; they are duly chronicled in another page. Turn we therefore, at once to the result, which, as we have already stated, amounted to the very considerable, if not unexampled sum of £13,232. Of this £5,624 were contributed by the Lodges in the Metropolitan district, and £7,608 by the Provinces. As regards the former we note that the House Committee, when totalled up, head the list with a satisfactory £143 17s. Lodges Nos. 73 and 79 share between them second honours, Bros. Free and Roberts, the respective representatives, each sending a list of £141 15s. Bro. F. J. Stohwasser Steward No. 567 gave £138 12s. Bro. Edmondston, acting on behalf of Lodge No. 1669, contributed £130, Brother W. H. Dean, Lodge No. 1900, being close at his heels with £129 3s 6d. Lodge No. 1475, per Bro. T. Jackson, is down for £119 14s, while Chapter No. 2, and Lodges Nos. 1524, 1686, and 1745 severally contribute one hundred guineas.

Bro. Augustus Darch's list for No. 72 totals up to £101, and there are others, such as Friends in Council Lodge, No. 1383, which exceed £90. It should be added that the list of our worthy Bro. Rev. C. J. Martyn, acting on behalf of Royal Alpha, No. 16, includes a contribution of 25 guineas from the Chairman, His Royal Highness the Duke of Connaught; and that Sir J. B. Monckton's list, as an unattached Steward, is swelled to the extent of 65 guineas by the contribution of £42, per Bro. the Lord Mayor, Grand Junior Warden, who has kindly undertaken to preside at the Boys' School.

Of the Provinces no less than thirty are represented. and among them they have subscribed the total of £7,608. Warwickshire enjoys the honour of heading the list, with the handsome total of £810 10s, the result of the labours of Lord Leigh and thirty-six other Stewards. Yorkshire (West) has contributed £650, and Yorkshire (N. and E.) £500. Berks and Bucks gives close on £200, and Cheshire nearer £300 than £200. Derbyshire figures well, for over £450; Sussex has done loyally in contributing about a score less pounds than £600. Middlesex is represented to the extent of over £400, Kent to that of £356, and "little" Herts by over £325. Staffordshire has handed in close on £290, and Hants and the Isle of Wight £273. North Wales and Salop, Notts, Northumberland, Devonshire, and Oxfordshire figure for £352 10s, £236, £183, £318, and £149 respectively. We are sorry to see that Cambridgeshire and Herefordshire are among the ab.

# GRAND LODGE DEPUTATION TO THE QUEEN.

S loval subjects of Her Majesty, it gives us the greatest pleasure to insert the following statement of particulars respecting the Deputation from the United Grand Lodge of England which, on Wednesday, waited upon the Queen at Buckingham Palace in order to express the heartfelt congratulations of all English Masons at Her Majesty's escape, under the Grand Architect of the Universe, from the hand of the would-be assassin. The Prince of Wales, as Grand Master, headed the phalanx of worthy Masons, and the address he delivered was most graciously received. Such addresses are, happily, of the very rarest occurrence, but Queen Victoria is not the only British Sovereign who has been approached by the authorised representatives of our glorious Fraternity. A similar congratu-lation was offered to George III., Grandfather of our Sovereign Lady the Queen, on a similar occasion, and it is needless to say that it experienced an equally gracious reception. We rejoice to say the interval between the two addresses we have in our mind is not far short of a century, yet do we equally rejoice that now, as then, the Mason Craft is to the fore in exhibiting its loyalty to the gracious ruler of the British Empire.

The following are the particulars as to the Deputation and the address it presented:—

The Queen received, at three o'clock, an address of congratulation from the United Grand Lodge of Antient and Accepted Masons of England, on Her Majesty's merciful preservation, on the 2nd of March. The deputation consisted of His Royal Highness the Prince of Wales M.W. Grand Master, His Royal Highness the Duke of Connaught Past Grand Senior Warden, the Earl of Carnarvon Pro Grand Master, the Earl of Lathom Deputy Grand Master, Lord Carriagton Grand Senior Warden, the Lord Mayor Grand Junior Warden, Bros. Æ. J. M'Intyre, Q.C., M.P., Grand Registra, Lieutenant-Colonel Creaton Grand Treasurer, Sir Albert Woods Grand Director of Ceremonies, Sir John Monckton President Board of General Purposes, Rev. Ambrose Hall Grand Chaplain, and Colonel Shadwell H. Clerke Grand Secretary. His Royal Highness Prince Leopold, Duke of Albany, Provincial Grand Master Oxford, the Earl of March Past G. Senior Warden, and the Hon. Bro. Justice Cave Past Grand Junior Warden, were unavoidably prevented from attending. The deputation on arrival was conducted to the Green Drawing Room, and from thence were introduced to Her Majesty's presence in the Picture Gallery, by Lord Sandhurst, Lord in Waiting. The Prince of Wales then read the following address:

"May it please your Majesty,—We, the Grand Master and Officers of the United Grand Lodge of Free and Accepted Masons of England, in the name and on behalf of our antient and honourable fraternity, yielding to no other body of Englishmen in loyalty to the Crown, and looking with pride to your Majesty as the Patron of our Order, hasten to lay at the feet of your Majesty the humble tribute of our horror and indignation at the recent dastardly attempt upon your Majesty's life, and we desire on this, the first occasion permitted to us, to add the expression of our loyal devotion to your Majesty's person.

"We believe that the Great Architect of the Universe rules alike the hearts of princes, directs the acts of men, and gnides the course of events; and in all humility we desire to record our unfeigned thankfulness to Him that in His mercy He has been pleased to turn aside the hand of the assassin and to protect from death or injury a life honoured in every part of the civilised world and most precious to every class and estate within this realm; and we would add to these thanks to Almighty God this further prayer that He in His goodness and wisdom may vouchsafe to your Majesty many years of health and strength to watch over the interests of a loyal and devoted people."

Her Majesty replied in the following words:—"I have received with gratification your loyal and dutiful address, and share with you the feeling of devout thankfulness to the Almighty, whose protecting hand has ever been so graciously extended to me."

The deputation then retired. Their Royal Highnessess the Princess of Wales and Princess Beatrice were present with her Majesty during the ceremony. The suite in attendance on Her Majesty consisted of the Dowager Duchess of Athole Lady in Waiting, Lord Sandhurst Lord in Waiting, Lord Edward Pelham Clinton Groom in Waiting, Lieutenant-General H. Lynedoch Gardiner and Colonel Hon. H. Byng Equerries in Waiting, General the Right Hon. Sir H. Ponsonby, and the Master of the Household.

At the meeting of the Claremont Lodge, held on the 8th instant, it was proposed by the I.P.M. Bro. T. Vincent, seconded by Bro. T. M. Collins, and unanimously agreed to, that an expression of congratulation be forwarded to H.R.H. the Duke of Albany on his marriage.

We very much regret to hear that our worthy Brother Fenner, manager of the firm of John Lillywhite and Co., has been recently overtaken by a severe bout of illness, and is suffering accordingly. Bro. Fenner has our full sympathy, and we trust he will be speedily restored to his usual state of health.

#### DISTRIBUTION OF HONOURS.

To the Editor of the Freemason's Chronicle.

DEAR SIR AND BROTHER, - "SENIOR P.M.," in your issue of 6th May, is wrong in saying, I am "put about" respecting the appointment of Prov. Grand Officers. We are but men, and certain duties we have to perform, and they who have the selection of Prov. Grand Officers should perform those duties with the greatest care, not merely selecting gentlemen who have, or are most likely, to contribute from their plenty, thereby baying the position and pushing to the back hard working and industrious Masons who have toiled hard for years. If positions are to be bought, why not ballot for them, and let the highest bidder take the coveted position? I hope and trust there are not any P.M.'s in West Yorkshire who will act upon the suggestion thrown out by "Sentor P.M.," and find it "necessary for some one in a Lodge to influence some one higher, &c. until it gets to the R.W.P.G.M." To act thus I consider a most debasing prostitution of Masonry. I am also of opinion that there is not one P.M. in our Province who would accept Provincial honours unless he was in a position to purchase his clothing, pay the fee of honour, and also do something for the Charities. There are many who would support the Charities were it not so very like buying Provincial honours. We all know, in our Province, that the P.M. who gives the most has the best chance when honours are distributed. I do not agree with Lodges being given the power of recommendation to the R.W.P.G.M. I consider the Prov. Grand Lodge should be able and wise enough to make a just and equitable selection, and I hope in future they will be able to give universal satisfaction. I have come to the conclusion that "Senior P.M." is some one in authority; he so distinctly says, "Junior P.M. need not expect to see any brother honoured, whatever his merits as a Mason, if he is only in moderate or poor oircomstances." I was not aware until now that Masonry made poverty a crime, which it must do if riches are to be the only test of qualification for Provincial honours. In conclusion, let me state that my former letter does not convey that the hard-working P.M. must necessarily be a poor man, and even should Prov. Grand Lodge meet with one in that unfortunate position, who has done long and honourable service for our Order, would it not be satisfactory to the Province that justice had been done by rewarding such industry with honours well and deservedly earned. I again thank you for your kindness in granting me space in your valuable paper, and I hope that this correspondence may have a satisfactory result, and that good may come, without creating any unkind or ungenerous feelings.

#### TRADING ON MASONRY.

To the Editor of the FREEMASON'S CHRONICLE.

DEAR SIR AND BROTHER,-Nothing, I think, is so objectionable as for members of the Craft to decorate their shops or places of business with such of its insignia as the Square and Compasses, the Level, the Plumb Rule, &c., their object being to proclaim that they are brethren, and, as such, should have, in preference to other tradesmen, the custom of their fellow Masons. I am not, of course, referring to such gentlemen as Bros. Geo. Kenning, Walter Spencer, H. T. Lamb, and others, whose business is wholly or principally the manufacture of Masonic goods, goods that is to say that are needed by the brethren to wear in our Lodges. In their case, if they exhibit some of our Craft emblems, it is a perfectly legitimate exhibition. What I object to see is the Square and Compasses staring me in the face over the windows of a chemist's shop, and elsewhere, but particularly objectionable to see them out and inside public houses. Indeed, no matter how thirsty I might happen to be, I would always go without, or go to some other house, rather than expend even the price of a modest glass of ale where Masonry is thus traded upon.

What, however, has induced me chiefly to write these few lines is, to tell you another phase of this "trading on Masonry," which came under my notice one day this week when I was walking in the neighbourhood of the Metropolitan Railway Station at King's Cross. Not a hundred miles—I may go so far as to say, not a hundred yards—off I noticed the shop of a picture dealer and picture-frame maker, in which, to my utter astonishment, was exhibited, as conspicuously as possible the shopkeeper's Grand Lodge certificate, signed by our late Brother John Hervey, with the Brother's signature in its proper place, and endorsed in an elaborate, or rather gandy, specimen of, I suppose, the owner's handiwork as a frame maker. I should like to hear of more being done to discourage this practice, which, as I have said before, is perfectly legitimate where adopted by brethren whose business is either wholly or principally Masonic in its character.

#### ROYAL MASONIC BENEVOLENT INSTITUTION.

THE General Committee met on Wednesday last, on which occasion Bro. Raynbam W. Stewart presided, and there was a large attendance of brethren, including Bros. Atkins, Cox, Newton, Quitmann, Gallant, Leggett, Dilley, Brett, Perceval, March, Mather, Lacey, J. A. Farnfield, W. H. Farnfield, Cubitt, Woodford, Cottebrane, Hale, Hine, Smith, Moon, Clarke, Crutch, Bolton, Adlard, Robbins, Daniel, Goode, Bush, Miller, Bowyer, Brockbank, Dennis, Hilton, Stevens, Stean, and Massey.

Bro. Terry, the Secretary, reported that four deaths had occurred amongst the annuitants since the last meeting, and that one approved candidate for election had died since presenting his petition.

Upon the Warden's report being read, in which the Steward's recent visit to the Institution was referred to, a vote of thanks to the House Committee of the Boys' School was proposed by Bro. Perceval, for allowing the Boys' Band to attend and perform at Croydon on that occasion. The motion having been seconded by Bro. Edgar Bowyer was carried unanimously.

The other principal business was the consideration of the Chairman's motion, of which due notice had been given—

"That, considering the great increase of work in the office, the Secretary's salary be increased £100 per annum from the 1st March 1882."

The executive of the Benevolent Institution recognise this fact, and hence the increment of salary, on which we take the liberty of offering Bro. Terry our congratulations.

Politics have no part in the programme of a Masonic journal; but this cannot be regarded as an obstacle to our obvious duty under the circumstances, which is to express our utter abhorrence of the atrocious crime committed on Saturday last in the capital of Ireland. Lord Frederick Cavendish, who had landed only a few hours previously in Dublin, and had been sworn into office as Chief Secretary to His Excellency the Lord Lieutenant, and who, moreover, is brother to our respected brother the Marquis of Hartington, M.P., Provincial Grand Master of Derbyshire, was murderously done to death in open day, and in close proximity to people who were leisurely enjoying themselves in the Phœnix Park. The Under Secretary, Mr. Burke, was slaughtered in like manner, and the bodies of the two deceased gentlemen were found lifeless and weltering in their blood within a few minutes after they had been seen walking and talking together on the most intimate terms The horror this foul deed has excited of friendship. throughout the length and breadth of Her Majesty's dominions, and in every foreign state, is beyond description. With the political business which has led to this terrible murder we have nothing to do, beyond expressing, in no uncertain tone, our belief that a cause which is attempted to be helped forward by such means must be utterly unworthy. We also feel ourselves justified, and, indeed, more than justified, in offering to the family, friends, and colleagues of the deceased Lord F. Cavendish, and his coadjutor, Mr. Burke, our sincere expression of sympathy at the terrible calamity which has thus plunged them into the deepest grief. May the G.A.O.T.U. give them strength to bear up in the midst and under the load of their present grief.

A History of Freemasonry in Oxfordshire. Compiled by E. L. Hawkins, M.A., P. Prov. Grand Registrar Oxon, W.M. 357, and 478, 33°, P. Prov. Grand Mark Sword Bearer Berks and Oxon, K.T., K.M. Published under the especial sanction of H.R.H. the Duke of Albany, K.G., R.W. Prov. Grand Master, the W. Deputy Prov. Grand Master, and the Worshipful Masters of the Lodges of the Province of Oxfordshire. Oxford: W. R. Bowden, 59 High-street.

BRO, HAWKINS is to be congratulated on the exceedingly able and incia manner in which he has dealt with the shoject of Fr in Oxfordshire. He has evidently made his task a labour of love, and though the result of his labours is compressed within narrow limits, he has succeeded in bringing together materials which form a complete sketch of the rise and progress of our Craft in this Province. Part I., though it occupies no more than thirteen pages, throws much light on the different Lodges which, at different times, have been established in the county, but are no longer in existence, though it is certain they have not passed away without having made their mark. Of these extinct Lodges there is no doubt that the "Lodge of Alfred," the predecessor of the present "Apollo University," and the "Constitution," which may be said to stand in a similar relation to the present "Alfred" were the most important. They were not the earliest, for there was a Lodge, No. 58, which was warranted on 8th August 1729, and met at the Crown, Corn Market, Oxford. It loes not figure in the List for 1740, and no records have been handed being able to be present at the opening of the Lodge, now came forward, and after being questioned was passed. Routine work 31st March 1740, and held its meetings at the White Liou,

Banbury; but this was erased from the roll of Grand Lodge "Moderns" on 27th January 1768, and no records remain. On 22nd December 1769, the Lodge of Alfred, in the University of Oxford, No. 455, was warranted, and the last entry in the Minute-book bears date 2nd April 1783, after which it appears to have collapsed. The complete minute books of this Lodge appear to belong the Apollo University Lodge, and from them we gather that Bros. Heroules Durham, Rev. Robert Markham, D.D., and Rev. Jas. Wood, M.A., were the first W. Master, Senior Warden, and Junior Warden respectively. It met, in the first instance, at the King's Head, Cornmarket, and towards the end of 1771 removed to the New Inn, Fish-street. In 1772 a medal was approved of, and it was ordered that forty of these should be struck off for the use of the Lodge. Only one known impression of this remains, and that was purchased by the Apollo University Lodge in 1881. Lodge appears to have taken a prominent part in raising the Grand Lodge Hall in Great Queen-street, the brethren being present on the occasion in academic costume, and an ode, composed by one of its members, being sung. In this Lodge as many as 103 brethren were initiated, and 32 joined its ranks from other parts.

The Constitution Lodge, No. 396, was warranted 17th March 1770, and continued to meet up to 1st August 1788, when the minutes and the Lodge "may be presumed to have collapsed." In it were initiated thirty-three brethren, and there were five joining members.

There were, in addition to these, the following Lodges warranted by the "Ancients," and of these only one survived the Union of 1813, having, however, since succumbed. These were No. 132, at the Ram, Chipping Norton, warranted 5th June 1771; No. 180, the Starr Cross Inn Lodge, Oxford, warranted 26th February 1773, and re-warranted 2nd April 1792; No. 185, Crown, Bicester, warranted 5th March 1774, became No. 224 at the Union, but was erased before 1832; the Duke of Atholl's Arms, No. 214, warranted 13th October 1781, but not on the Union list; and No. 660, meeting at the Cock Inn, Banbury, which was warranted in 1815, and erased from the roll of Grand Lodge on the 5th March 1858. Thus nine Lodges have at different times been established in Oxfordshire, which have doubtless done good service on behalf of the Craft, but which are now no longer in existence.

The rest of Bro. Hawkins's sketch treats of Masonry as it exists, not only Craft, but Archand Mark Masonry, and the High Degrees. The record is one of which Oxfordshire has every reason to be proud, especially as it is supplemented by particulars respecting the good things done by the Province in aid of our Charitable Institutions. In fine, the work has been most carefully compiled, and Bro. Hawkins may congratulate himself on having had the services of so able a typographer and publisher to reproduce his brief, but valuable, contribution to Masonic history.

Yet it is so well compiled, the notes, which are concisely written, but without undue elaboration, are so clear and so full of the necessary information, that, in spite of its being a religious work and therefore outside the legitimate scope of a Masonic journal's notice, we do not hesitate to express a most favourable opinion of its contents. We have looked carefully through its pages, and we have come to the conclusion that it will prove a worthy addition to the library of every student of Biblical Literature.

Bulkeley Hughes, M.P., R.W.P.G.M.M.M., on their afflicting bereavement."

At this time the hall presented a most brilliant appearance, the pale blue and silver clothing of the English Masons contrasting with the varied colours worn by their Scottish brethren, having a good effect; added to these, the rich clothing worn by the Grand Officers of the different Constitutions rendered it a scene diffi. cult to depict. The daïs was occupied by the following exalted brethren: -G. W. Harvey, V. Pyke, J. Gore, L. Court and J. Mills, together with a large number of past and present Grand Officers of both Scotch and English Constitutions; while in the body of the hall, on either side, were ranged in their order of precedence the various Craft Lodges, special seats being reserved for the Board of Grand Stewards and the Masters and Past Masters of Lodges. The musical arrangements were under the direction of Bro. J. Riedel W.M. of the Lodge of Dunedin and District Grand Organist, who was ably assisted by Bros. Marsden, Ferguson, Braid, G. Israel, A. R. Kelsey, F. Lewis, G. Pallett, M. Menderhaussen, W. Kneen, R. Greig, F. R. Smith, W. Harold, J. Horsburgh, W. Hoffland, R. Rae and Signor Riccardi. The whole of the ceremonial was carried out under the supervision of Bro. C. de Longueville Graham D.G. Director of Ceremonies, Bro. W. L. Buchanan acting as Assistant Director of Ceremonies, Bros. C. Coombs and A. George as Heralds. Bro. George P. Pierce P.G.M. New Zealand, Irish Constitution, was then announced and received, taking the chair as Installing Officer; and the approach of the new District Grand Master was announced by sound of trumpet, in answer to which Bro. #### PRINCE EDWARD OF SAXE-WEIMAR LODGE.

THE installation of the second W.M. of this Lodge (which, it will be remembered was constituted.) be remembered, was constituted in May of last year, under very auspicious circumstances, Bro. Bourke P.M., seconded by Bro. Townsend P.M., a hearty vote of thanks was accorded to the Prov. G.M. and his Officers for their attendance. The Prov. G.M., who was received with much cheering, said he thanked them heartily for the Masonic greet. ing which they had given him and the Provincial Grand Officers. He expressed the deep regret of the Deputy P.G.M. (Bro. W. Hickman) at his inability to attend, in consequence of important business which detained him in London. It had given him great pleasure to attend that day. He had little doubt, when the Lodge was first constituted. that it would be successful, owing to the manner in which it was supported, and the great desire which he saw on every side to promote its best interests. Now he had the pleasure of congratulating them on the success which had attended the Lodge. During the past year. he understood, no less than eleven candidates had been initiated, and showed the interest that had been taken in the prosperity of the the past twelve months Bro. Page had carried out the duties of S.W. the number of visiting brethren from all parts who had attended

Lodge. He congratulated them also upon the admirable manner in which the ceremony of installation had been conducted that day by Bro. Townsend, and upon the manner in which every Officer had discharged his duty. He thought they might well augur from this that the future of the Lodge would be attended with great and signal success. The Lodge was then closed in due form.

At the conclusion of the ceremony of installation an adjournment took place to the Lecture Hall of the Soldiers' Institute, where the banquet was served. The catering was entrusted to Bro. W. Maybour, of Butcher-street, Portsea, who placed upon the table an elegant repast, the general arrangements being satisfactory, and the wines of the finest quality. The caterer was highly complimented upon the manner in which the banquet was served. The draping of the sides of the hall with coloured bunting and flags of all nations, and the decorations of the front of the galleries with shields and bannerets, produced a very imposing and pleasing effect, while at the rear of the W.M. was the exceedingly handsome banner of the Prince Edward of Saxe-Weimar Ledge. The tables, adorned with plate and choice flowers, presented a very pretty appearance. The end gallery was occupied by the full band of the Gordon Highlanders, the side galleries being reserved for members of the fair sex, who were libe. rally supplied with light refreshments by the W.M., who was sup. ported by the R.W. the Provincial Grand Master and the Provincial Officers, Bro. Colonel Bray and Bro. Martyr, by virtue of their offices as Senior and Junior Wardens, occupying the posts of vice chairmen. The company included some members of the Craft who were not able to attend the Lodge. At the conclusion of the banquet the W.M., in appropriate terms, gave the Queen and the Craft. He next proposed the Most Worshipful Grand Master H.R.H. the Prince of Wales, K.G., K.T., &c., alluding to the honour which His Royal Highness had conferred upon the Lodge by his recent visit. Captain Haldane gave the Right Hon. the Earl of Carnarvon Pro Grand Master, the Earl of Lathom D.P.G.M., and the Officers of Grand Lodge, remarking that wherever the names of those distinguished brethren appeared in connection with Freemasonry, there they might be sure the Craft would be in the ascendant. Brother H. W. Townsend, in proposing the Right Worshipfal Provincial Grand Master Bro. W. W. Beach, M.P., referred to the valuable and ready assistance given by the P.G.M. to any Lodge in his Province, and said that the Prince Edward of Saxe-Weimar Lodge, as a new Lodge, had much cause to be thankful for the manner in which he had acted towards it. The Prov. G.M., who was received with much enthusiasm, responded. It gave him, he said, the utmost pleasure to attend the ceremony at that the first anniversary of the Lodge, and he thought, from the success which had attended it hitherto, there was every reason to anticipate that ere long it would become one of the most thriving Lodges in the Province. He trusted that that would not be the last occasion on which he should have the pleasure of being present. It was a subject of inquiry to some in the present day how it was that while, in the history of the world, so many societies had sprung into existence and passed away, Freemasonry had continued to flourish, and had successfully resisted the destroying hand of time. Many of these societies, as they knew, had heen secret ones. Some of them had been called into existence for benevolent purposes, and some had been started against Sovereigns and against the peace and order of society. One reason why Freemasonry had continued to flourish was because it could boast that loyalty to the Sovereign and reverence for the existing Institutions were its distinguishing features. Attempts had been made in many parts of the world to misrepresent Freemasonry, by charging it with perarious projects against society in general, and especially against those who were placed at the head of society. But all attempts had signally failed, and if there was one fact more than another calculated to refute the accusations of which he had spoken, it was that the Heir to the Throne of England had placed himself at the head of their Institution. Without entering into the principles upon which Freemasonry was founded, he might simply say that those principles had been fully kept in view from the earliest years up to the present time, and he sincerely trusted that they would be maintained so long as the world existed. Those principles were such as could not fail to prove beneficial to society at large, seeing that charity and good fellowship were the groundwork of everything connected with the Institution. It was a matter of pride as well as of pleasure to him to be charged with administering the affairs of Freemasons in the Province of Hampshire and the Isle of Wight, and so long as he had held that position, he had striven so to discharge the duties imposed upon him as to satisfy his conscience and to afford satisfaction to the brethren generally. Of course, he could do but little without the cordial co-operation and assistance of his Officers and the brethren of the various Lodges. But so long as he was fortunate enough to secure that co-operation and assistance he would continue to do his utmost to promote the cause of Freemasonry in the Province. Bro. G. L. Green, in proposing the Right Worshipful Deputy Grand Master Bro. W. Hickman, and Officers of Provincial Grand Lodge, congratulated the W.M. (Bro. Page) upon his bol reference to the admission of ladies, which had enabled them to listen to an eloquent exposition by the P.G.M. of the principles of Free-masonry—Loyalty to the Throne, Brotherly Love, Relief, and Truth which must, he submitted, be at the foundation of all well-constituted societies. After referring to the respect in which Bro. Hickman was held in Southampton, he said the P.G.M. was fortunate in having so able and efficient a Deputy, and he expressed the opinion that the P.G.M., by his devotion to the cause of Freemasonry, had a claim to the loyal and hearty support of the Craft. Bro. Dr. Jacob O'Connor made a suitable response. Bro. H. W. Townsend, in introducing the W.M., said it had been his privilege to instal into the chair of K.S. one of the oldest and best friends he had in the borough. To know Bro. Page was to respect and love him. He (Bro. Page) enjoyed the proud position of having been selected to fill the high office of W.M. by the unanimous vote of the brethren, and he was sure that his selection augured well for the future success of the Lodge. 


