#### THE MASONIC INSTITUTIONS AND THEIR PROSPECTS.

FOR all practical purposes as regards finances the current year may be said to be over. True we have, from to-day, still three weeks to run ere the total record for the year is set down, but to those who are conversant with the working of our three Central Institutions the task will not be a hard one to forecast the result. It would be a difficult, indeed a somewhat hopeless task, did we attempt to question or in any way to disparage what has been done by those who have so zealously and consistently banded themselves together to find the necessary funds demanded heretofore by the Institutions for current yearly expenses, but inasmuch as it is continuously being urged upon us that the poor are always with us, we must not close our ears to the wails of those who have been overtaken by misfortune and who in their downhill of life can look forward only to such assistance as the Craft may be able to provide for them. It is on behalf of this large constituency therefore that on this occasion we

exercise our pen.

First, then, let us take a retrospective glance at the work done during the current year, which year opened with a cheery prospect that the efforts made to adequately celebrate the Jubilee Festival of the Royal Masonic Benevolent Institution were receiving the attention so important an event in the history of our Institution demanded. In the year 1891 the total amount subscribed for the youngest of our Institutions was returned at £22,238 14s 5d. The 1892 Festival was fixed for the 24th February; Bro. Terry and his Committee had secured the services of the Rt. Hon. the Earl of Mount Edgcumbe, Deputy Grand Master, for Chairman. But now came the crucial question, where shall the Festival be held? After this knotty point had received due consideration, the aid of Sir Augustus Harris was invoked, and that worthy brother suggested that if certain technical difficulties could be overcome, he was prepared to place at the disposal of the Festival Committee Covent Garden Theatre. It is now matter of history that in due course the Festival was held, and the result, from a financial point of view, was far beyond anything that had been anticipated. The second Festival of the year, that on behalf of the Royal Masonic Institution for Girls, was held on the 18th May, under the presidency of His Royal Highness the Duke of Connaught, K.G., P.G.M., and the result of the exertions of the Board of Stewards who supported His Royal Highness on that occasion was returned at £10,000. On the 29th June the third Festival was celebrated, that on behalf of the Royal Masonic Institution for Boys, and here the services of Sir Michael E. Hicks-Beach, Bart., Prov. Grand Master for Gloucestershire, had been secured, while the result of the Festival showed that £12,212 had been Club Lodge, No. 2190, on the 6th inst.

contributed. In the year 1891 the Boys' School may be said to have had its innings, the total subscribed from all sources being returned at £27,333 11s 3d, this desirable result having been achieved in some measure through the filip given to the Stewards' exertions by the fact that a new régimé was inaugurated in regard to the management of the Charity. Now, when we combine these results we cannot be insensible to the munificence displayed by the Craft in its corporate capacity, but the future is before us, and it was the future we desired to look into when we entered upon our task for to-day.

Well, then, the Festival for Bro. Terry's Institution, the Benevolent, will take place in February next, and, according to the precedent laid down, and we may say universally accepted, that the Festival next on the rota should claim our first care, we look now to the prospect. At the time of writing we learn that Bro. Terry has not yet secured the services of a Chairman; that the number of Stewards who have as yet handed in their names is far below what the average has been in recent years at the same period, and the list of applicants for the benefits of the Institution is abnormally large, while the vacancies to be filled in May next are but eleven. Clearly then there is a good field for earnest workers, and we trust that many such will enrol themselves before we reach the close of the year.

Both the Scholastic Institutions may be said to be better circumstanced; in each case a Chairman has declared himself, and the champions are doing all they can by preliminary work to command that success we all so ardently desire shall attend the efforts made. The Girls' School Festival will be held in May, and on that occasion the Right Hon. the Earl of Euston, D.L., R.W. Prov. Grand Master Norths and Hunts will preside. For the Boys' School Festival, to be held in June, Bro. J. M. McLeod, the Secretary, announces that Lord Brooke. Provincial Grand Master for Essex, has kindly offered his services. Both these brethren are popular, not only in their respective Provinces but throughout the Craft, and we confidently look forward to both

being able to secure a strong following.

#### VICTORY-CROWNED.

Half a Century's Aspirations and Hopes Realized. An Address by Bro. James Ten Eyck, Grand Master, at the Dedication of the Masonic Home at Utica, New York, 5th October 1892.

BUT the anti-Masonic outbreak and craze, of which I have briefly spoken, by way of illustration, did not really belong to the nineteenth century. Its proper place was away back in the middle ages, when superstition was general, when men were governed mainly by bigotry the length of my remarks. There is an old saying that and prejudice, and when toleration and forbearance among those who ruled were rarely practised, and were indeed virtues scarcely known. Certain it was that no such delusion could take permanent root and flourish in this land of liberty and enlightenment. Our air was too pure and free for its continued existence; our soil too rich and precious to be given over to the nurture of so noxious a

And now behold, brethren, how that which is essentially evil may be transformed into proclamation the merit of the work of His servants. In a little time after the episode to which I have referred, Freemasonry was stronger and in a more flourishing condition in this country than ever before. Lodges increased and multiplied, and membership grew apace. Those who had been our bitter enemies, convinced that they had been deceived and misled, became our friends, and denounced themselves for having been led astray through ignorance and by passions that

ought to have been kept under control.

And what a world of good the Order has accomplished in this State alone during the last half century! The sick have been tenderly nursed, the hungry fed, the naked clad, the dead buried. A magnificent temple for the Grand Lodge has been erected in New York city—a structure which is a credit to the Order and an ornament to the metropolis. Throughout the State other temples of great beauty and great utility have been erected or projected,

and the good work is constantly going on.

And here let me remind you, brethren, that the charity of our grand organization never ceases—that its good work is never done. To-day we dedicate to its pure and unselfish purposes this building, the dream of years; tomorrow we must, in a certain sense, forget what we have done, look about us and determine what next demands our aid and assistance, and then bring all our energies to bear in furtherance of the new project. We have no years to waste in complacently reflecting upon how much good we have accomplished. Rather in the other direction should our thoughts lie, and we be planning and devising the next great undertaking.

So, brethren, gird up your loins for advancement, remembering that there are yet other battles to be fought and victories to be won in the cause of pure morality and sweet charity. He is not a good husbandman who, having put his hand to the plough, turns to look backward; and neither is he the highest type of a Freemason who, satisfied with what the Order has accomplished so far, would call a halt and take a rest. There should be no halting nor faltering in the pursuit of good works; we must keep on

stedfastly to the end.

There is a peculiar blending of conservatism and progressiveness in Freemasonry which it is extremely difficult for those who are not members of the Order to comprehend. To the brethren, however, the matter is plain and simple. The ancient landmarks, established forbidden. and leading part, while in loyalty to God and country it stands second to no other organisation. It is this happy combination of wise and enlightened conservatism and judicious yet uncramped progressiveness that constitutes one of the towers of strength of the Order. Just as the fusing of certain metals gives increased strength and durability, so the commingling of conservatism and progressiveness has given increased strength and vitality to the Order. The plan is so happily balanced and adjusted that friction at no time results. Everything works smoothly and in the most orderly manner.

Brethren, I fear I have overtaxed your patience with "Short visits make long friends," and the aphorism may be applied to addresses as well. The theme upon which I have spoken is an inspiring one, and, once started upon it, one knows scarcely when or where to stop. But, in closing, permit me to return thanks for the patience and attention with which you have listened to me. This day will be one that will live long in my memory, and, I need

not assure you, most pleasurably.

At the risk of repetition, however, let me once more remind you that there must be no permanent halt in the onward march of our great column of progress and

charity.

Freemasonry has asserted itself before the entire civiliand world, and we who are its representatives and to a certain extent its exponents, must see to it that those assertions are not meaningless. What the next great undertaking of the Order may be I do not know, but I do believe that it will be inaugurated without great loss of time, that it will be broadly philanthropic, be grandly conceived and gloriously carried out. #### INSTALLATION.

ODGE members have elected the Officers of their Lodges. Now they are to be installed.

On or before St. John's Day the law requires that these elected officers shall be properly prepared for their respective stations.

It is the ceremony of installation that completes the requisites for taking the stations and exercising the duty attached to each.

Installation is a Masonic ceremony. It is part of the esoteric work of a Lodge. As a ceremony, it is the clothing of the symbol of a perfected election to the chairs, by the members of Lodges. Without it the Officer of a Lodge cannot take the station to which he was elected.

The philosophy of the Masonic ritual is to make perfect the inchoate action described by Masonic law, that the

members elect the Lodge Officers.

But the election is not in itself the completed requisite for taking the chairs. Therefore the ceremony of installation is prescribed. This being so important a proceeding, it should be conducted with the propriety and fullness belonging to its character. Of course no public recital of the proceedings is permitted. To explain it here is portance of properly performing it.

It must be as elaborate as the Ahiman Rezon prescribes. be completely and solemnly performed. It cannot be done in part, or indeed, any part be omitted; if so, it is not complete. If not exhaustive of the ordained requirements, it is not a lawful installation. It destroys the very significance of the proceeding. The part is not the whole, and the whole work of installation must be performed, or why make it necessary? The "charge" to the Master on his installation should be read to him. This ought never to be omitted. If a Lodge has not the time to do the work, or such an excuse is made for the omission of any of the ordained ceremonies, it is a serious error.

If Lodges have not time to do the work, then it should be postponed till the opportunity to do it all, and do it well, is secured.

If an evil is permitted to exist, it grows if not corrected. So it comes to pass that here a little and there a little of disobedience to the established regulations begets greater evils, till at last innovations are not regarded as blights on the perfection of Masonic ceremonials or destructive of

It is not wise to countenance the slightest neglect of the established rules of the Craft, especially in the performance of the ritual. Once it happens that omissions are permitted, it is cited as a precedent. It is contended that as such a Lodge did its work without correction, another Lodge may by that example omit in its work what is essential to its perfected performance. So by degrees innovations creep in, and by and by they obtain a sort of authoritative andorsement.

If at the installation of the Officers of Lodges any part of the ceremonial is omitted, what may be expected of the future obedience of the Lodges to those regulations that

Masonic authority has commanded?

As Lodges are now about to instal their Officers, the occasion should be taken to impress on the members the duty of obedience to the established regulations which govern Lodge action in all its labours. Especially should adherents than ever before. he who instals know exactly what the ancient regulations require in the ceremony. A careful examination of these regulations as well as of all the ceremonial of the Craft should be the study of the Officers of Lodges. Thus only can the laws be enforced.—Keystone.

#### CENTENARY OF THE PALLADIAN CHAPTER, No. 120.

ON Monday afternoon, the 21st ult., at the Green Dragon Hotel, Hereford, a convocation of the Palladian Chapter was held, in celebration of the Chapter having recently obtained a Centenary Warrant of the Supreme Grand Chapter, bearing the signature of the Prince of Wales as First Grand Principal. This rare occurrence in the history of Freemasonry brought together a large number of the members of the Royal Arch Order, also Visitors from the adjoining counties of Monmonth, Worcester, Gloucester, Somerset, and Salop.

Brother William Margrett, of the Grey Friars' Lodge, and Brother H. J. Gifford, of the Palladian Lodge, were unanimously elected and exalted to the Supreme degree of Royal Arch Masonry by Comp.

J. A. White and other Principals.

Comp. Captain S. George Homfray P.G. Standard Bearer and P.G.H. Monmouth performed the interesting ceremony of presenting the Centenary Warrant on behalf of the Supreme Grand Chapter. He said he congratulated them upon having proved a hundred years' uninterrupted service, and he added that the Warrant bore the signature of the Prince of Wales 1st Grand Principal, and the time-honoured names of Comps. Lord Mount Edgeumbe and W. Withers Beech.

The Warrant having been received by the S.E. Comp. W. Parlby, Captain Homfray said that on becoming a Freemason they passed through the degrees of E.A., F.C., and in due time arrived at the sublime degree of M.M.; still they were not in possession of the genuine secrets until they joined the sublime degree. The Centenary Warrant woul enable the Chapter to rank amongst the few who had attained this honour, and he trusted that it would be faithfully preserved and handed down to successors in office pure and unsullied.

Comp. J. A. White, the First Principal of the Palladian Chapter, rising to reply said, on behalf of the Principals and Companions of the Palladian Chapter, that it was with very great pride and pleasure that he accepted the Centenary Warrant. The document or charter would be most highly prized by the Companions of this Chapter. Companion William Parlby said the pleasing task devolved upon him

to submit a few particulars relative to the history and growth of the Palladian Chapter. It was stated in Gould's work on the History of Freemasonry, that the earliest Royal Arch minutes were to be found among the York records, the degree being traced back to the year 1762. In the county of Hereford Royal Arch Masonry might be said to commence from the year 1791, when the Palladian Chapter came into existence, the Lodge and Chapter taking the name after Palladio, the famous Italian architect, who was born in the year 1580, and it might be said to be among the oldest in existence. The minutes of the Chapter, though exceedingly meagre in the earlier years of its history, had been preserved from 1791. It appeared that on 13th August 1791, in virtue of a Warraut of Dispensation, a Grand Chapter of Royal Arch Masons was held in this City, when M.E. Companion Thomas Callender was appointed Deputy Grand Superintendent for the County of Hereford. Dunckerley, who was designated in the minutes as G. Superintendent, was not only Provincial Grand Superintendent of Royal Arch Masons for the County of Hereford, but Provincial Grand Superintendent for the City and County of Bristol, and numerous other counties, and, at the same time, Provincial Grand Master in eight Provinces. In Sadler's "Life of Dunckerley" it is stated that at the time of his appointment (1790) there was only one Lodge in the whole county of Hereford to occupy his attention, and that was the Palladian. At the present time there are five Lodges. The same authority states that on 28th January 1791, a Lodge was constituted at Kington, but it did not appear to have long survived, as the Warrant was soon after transferred to Ludlow, and the title changed to that of the Mercian Lodge. Here it continued for some years, but was finally erased in 1832. The same authority states that in 1793 Dunckerley applied for a Warrant of Constitution for the Royal Edward Lodge to be held at Leominster, which continued for a time to flourish, when it was erased by Grand Lodge. In both these Herefordshire towns, however, Masonry has since revived. Under date 7th February 1792, the following entry occurs in the minute book of the Chapter:-- " By virtue of a Warrant of Dispensation for holding a Royal Arch Chapter (under the denomination of the Palladian Chapter), granted by Thomas Dunckerley, Esq., Grand Superintendent, the Companions assembled this day and exalted Brother William Thomas, and the Exaltation being completed, the Most Excellent Z. moved that the blank left in the Warrant of Constitution for the days on which this Chapter should in future meet, should be thus filled up, as follows, viz.: That the next meeting be on the 21st instant, and the future meetings on the 3rd Tuesday in every month from that date. This motion was put in due form and unanimously approved. Most Excellent Z. then moved that 15s per annum be paid by each Companion as a subscription fee, which being seconded and put in due form, was unanimously approved. The original Charter contained the names of the Rev. Richard Underwood, Mr. Robert Phillip, and the Rev. Thomas Kidley, who were the first respective Principals of the Chapter, and is dated 14th August. In the first instance, and indeed for many years, the regular Convocations of the Chapter were held at the Bowling Green Tavern. From time to time, brethren connected with the Palladian, Silurian, Royal Edward, Vitruvian, and Eastnor Lodge, in the county, and also brethren from the Masonic Lodges of Gloucester and Worcester had been exalted to the Supreme Degree of Royal Arch Masonry in the Chapter. That virtue, so truly characteristic of a Royal Arch Mason's heart—Charity—had been a moving principle in the Chapter from the first. In 1808 a sum of £15 was voted to the widow of a Companion. At the Chapter held on the 15th of February 1814, it was ordered that £5 should be presented to Companion John Cann, who had broken his leg by a fall in the late severe weather. In 1816 a Chapter of Emergency was convened for 13th March for the pur-

pose of celebrating the seventy-second anniversary of the Reverend Richard Underwood, who, it was recorded, desired to be discontinued a member of the Chapter, after having filled the office of First Principal for nearly twenty-five years. As an instance of the largeheartedness and generosity of the Companions, he might mention the following incident which was recorded in the minutes about this time. After the conclusion of the formal business of the Chapter, the Janitor requested that he might be allowed to introduce his daughter for the purpose of affording the Companions a little music upon the harp, and it was recorded that the performance proved so highly entertaining that in order to encourage the young lady to further progress, the Companions present subscribed the sum of £15 17s 6d to enable her to purchase the instrument. An incident of another kind might be narrated as indicating that the Principals were wishful to maintain a becoming dignity in the ceremonial of the Chapter. In 1819 an inventory was made of the articles belonging to the Chapter, and it was ordered "that three proper caps or head dresses be procured for the three Principals, as used in the Chapters in London, and also the same for the Scribes." By reference to the historical work he had alluded to he found that on 18th March 1817, the two Grand Chapters amalgamated under the title of the United Grand Chapter of Royal Arch Masons of England. Hence very soon after—in 1821—a new Charter was granted by the Grand Chapter to the Palladian Chapter. The Warrant was an interesting document, being the Charter of their privileges, and should be perused by every Companion. Having carefully compared the two Charters, he found there was a slight alteration in the wording of the 1821 Charter as compared with that of 1791. In the first Charter the object of the Companions was described as "to extend their aid to and promote the happiness of every terrestrial being and link mankind together by indiagolable Bonds of Friendship, Peace, and Love." In the second Charter the object was described as "to extend their aid to and promote the happiness of all our Brethren and link mankind together by indissoluble Bonds of Friendship, Peace, and Harmony. The following incident ought not to be overlooked, as by it they became acquainted with the origin of one of the indispensable instruments possessed by the Chapter:—"In the year 1823 Companion John Allen, Jun., presented as his parting gift to the Companions, a black hilted sword and sheath for the use of the Janitors." In 1833, Companion Bird was elected to the office of First Principal of the Chapter, and again in the year 1834 that same distinguished Companion appeared to have attended the Chapter in the capacity of Grand Superintendent of Royal Arch Masons for the county. In the same year (1834) the kindly feeling of the Companions manifested itself by the presentation of a silver cup to Companion Jas. Maddy for services rendered to the Chapter for a period of thirty years. The year 1834 seems to have been an important one in the history of the Chapter, not only because of the incidents mentioned but also on account of the exaltation of a brother as a compliment or mark of respect. In the year Mr. Radford was unanimously elected and duly exalted a member of the Chapter as a compliment to him in consequence of his exertions for the good of his fellow citizens in erecting an iron foundry in the city. The first stone of the building was laid in Masonic order on 11th June 1834. During this year the Chapter ordered that all Institutions relative to the regulations of Royal Arch Masons received from the Grand Chapter be entered in a book provided for that purpose, and the letters conveying any such orders or regulations be kept and numbered for reference, but the book did not appear to be in evidence. Chapter began to hold its convocations in the Green Dragon Hotel in 1837. The following year the Principals of the Chapter were deputed to meet the Officers of the Palladian Lodge to make arrangements for a procession at the celebration of the Coronation of the Queen, on 28th June. In 1844 Mr. Thomas Duckham was elected and exalted in the Chapter, and he thought that Mr. Duckham was the oldest Royal Arch Massa in Hereford, who was at one time connected with the Royal Arch Chapter. In 1859 Mr. Henry connected with the Royal Arch Chapter. In 1859 Mr. Henry Clarkson was also elected and exalted. Each of these Companions oventually filled the chair of the First Principal. In the year 1860 the present R.W. Deputy Prov. Grand Master for Herefordshire, Comp. S. H. Piper, was elected a member of the Chapter. In the same year the Rev. Richard Lano Freer, D.D., Archdeacon of Hereford, became a joining member. In 1863 the sum of £10 was subscribed towards the memorial window placed in the Hereford Cathedral to his memory. In the year 1864 the then R.W.P. Grand Master of Herefordshire, the Rov. Dr. Bowles, was elected a Companion of the Chapter. Companion Shellard P.Z. P.P.S.G.W., the esteemed Treasurer of this Chapter, was exalted in the year 1864. In 1870 the Rev. Dr. Bowles P.Z. communicated to the Chapter the fact of his having been appointed Provincial Grand Superintendent, the patent of his appointment being read in open Chapter. In 1873 a Committee was appointed to revise the byelaws, and in 1875 the thanks of the Chapter were accorded to Companion Burville for his length ned services as Scribe E. In 1873 the Rev. Dr. Bowles Provincial Grand Superintendent P.Z., owing to the infirmities of age, retired from active membership. In the year 1876 the Rev. J. Buckle, the First Principal, presente I a beautiful banner to the Companions, depicting the "Triple Tau." Upon the decease of Dr. Bowles, 1879, the Companions passed a resolution recording their sense of the great loss the Chapter had sustained by going into Masonic mourning for the remainder of the year. In 1882 Sir Joseph R. Bailey was elected as joining member of this Chapter, and in 1887 the Rev. Richard Evans was appointed an Assistant Grand Sojourner of Supreme Grand Chapter. In 1888, 1889, and 1890, the byelaws of this Chapter were under revision, and were confirmed as they now stand on 20th November 1890. In 1891 a correspondence was opened by the Chapter with the Chapters of Shropshire, with the view of an association of the Chapters of Shropshire and Herefordshire, in order to form a Provincial Grand Chapter, but without success. The total number of subscribing members now connected with the Chapter was 36. This year, as our proceedings testified, would be considered one of the most important in the history of the

Chapter, marking an epoch in the development of Royal Arch Masonry in Herefordshire which will not soon be forgotten, but it is hoped will bear fruit in years to come.

The thanks of the Chapter were given to the S.E. for his interesting history of the Chapter, and it was decided that it be printed in book form, and that a copy be sent to each member and to the Visitors present from neighbouring Chapters.

Comp. Capt. Homfray was elected an honorary member of the

Chapter, and presented with a centenary jewel.

The Centenary Warrant was ordered to be suitably framed and hung up in the Chapter.

The election of Officers and other formal business was next proceeded with, after which the members and visitors sat down to a banquet to which they had been invited by the Present and Past Principals of the Chapter, in celebration of the Centenary. #### THE FRASCATI RESTAURANT.

IT would, at the present time, be hard to find a place that is more elaborately and artistically fitted up than the new Frascati Restaurant, which is situated on the northern side of Oxford Street, fifty yards from Tottenham Court Road. The main hall is called the Winter Garden, and certain it is that this name is adequately adapted for it, for the vast hall is so liberally decorated with ferns, palms, and shrubs of all descriptions, that it makes us feel as if we were seated in some large garden. It is needless to say that the electric light is laid on all over the building, and in the large hall alone there are nearly 1,000 incandescent lamps. The ground floor of this hall is occupied as a Café Restaurant, while the balcony is reserved for table d'hote and French dinners. These dinners are of the most sumptuous kind, and served in a way that does infinite credit to the management. A capital band, under the direction of Bro. Henry Tinney, gives a selection of music between six and ten, so it will be seen that everything is done for the comfort of the visitors. The Francati has also a luncheon buffet, and here the most careful man may have no fear of being charged a high price for his "snack,' for we notice that the prices are exceedingly low. The billiard room, containing five English and three French tables, is also made most comfortable, while the ladies toilet room is one of the best fitted we ever remember to have seen. The grand banqueting hall, capable of dining 150 guests, is at times used for balls, and we feel sure that the room is adequately adapted for the purposes it is put to. But what, perhaps, is of most interest to our readers is the Masonic Hall, and here we find everything as it should be. The hall is cosy, and admirably suited for a Masonic home, and we feel sure that when it is better known the Frascati will have several of our London Lodges meeting in its hall; at present the Tivoli is the only Lodge meeting there. In addition to the rooms we have mentioned, private salons for club and society dinners, wedding breakfasts, and family dinner parties can be had, and from what we saw of these rooms on the occasion of our visit we feel sure they will give the greatest satisfaction. The cuisine is of the very best quality, in fact, we have only to mention that the proprietary is the same as that at the Holborn Restaurant to show that everything is bound to be first class. The manager is Bro. Gustave F. Lambert, and we feel sure that with his vast experience visitors to the Frascati will not want for anything. We trust Bro. Lambert, who is ably assisted by Mr. Hamp jun., will long be in command, and that the fortunes of the Frascati will greatly increase under his able guidance.

THE Quarterly Communication of United Grand Lodge was held on Wednesday evening, at Freemasons' Hall. The Earl of Lathom Pro Grand Master presided. The Earl of Mount Edgcumbe D.G.M., and Bro. W. W. Beach, M.P., acting as Past G.M., the Hon. W. T. Orde-Powlett P.G.W. as G.S.W., and Sir E. A. Inglefield as G.J.W., Sir Albert Woods G.D.C., F. A. Philbrick, Q.C., G.R., Thos. Fenn President of the Board of General Purposes, E. Letchworth G.S., and other Grand Officers were in their respective places. There was an exceptionally large attendance of brethren. After the minutes of the Quarterly Communication of 7th September having, with a small alteration urged by Bro. Richard Eve P.G.T., been read and confirmed, Bro. T. L. Wilkinson nominated the Prince of Wales for M.W.G.M. for the ensuing year. Bro. Davis nominated Bro. The next business was the discussion of the following Report of the Board of General Purposes :-

To the United Grand Lodge of Ancient Free and Accepted Masons of England.

The proposition of the Most Worshipful Grand Master, respecting the appointment of six additional Grand Officers, not having been accepted by Grand Lodge at the last Quarterly Communication, the President of the Board laid a report of the proceedings before the Most Worshipful Pro Grand Master, and requested his instructions.

The Most Worshipful Pro Grand Master, believing that Grand Lodge must have been acting under some misapprehension, desired the Board to submit the proposition again to Grand Lodge, with some modifications which his Lordship believes will be generally

The proposition which the board now recommend for adoption is as

followa:-

"That an addition be made to the Grand Officers appointed by the Most Worshipful Grand Master, by the appointment of a Desuty Grand Registrar, to rank immediately after the Grand Registrar, Two additional Grand Deacons, Two additional Assistant Grand Direct as of Ceremonies, and a Deputy Grand Sword Bearer, and that the same take effect on and after the Grand Festival of 1893."

"That in Provinces and Districts numbering 40 Lodges and upwards the Provincial and District Grand Masters shall be empowered to appoint annually Two additional Provincial or District Assistant Grand Directors of Ceremonies. In Provinces and Districts numbering 70 Lodges and upwards the Provincial and District Grand Masters shall be empowered to appoint Two Additional Provincial or District Grand Deacons, and Two Additional Provincial or District Assistant Grand Directors of Ceremonies. In Provinces and Districts numbering 100 Lodges and upwards, the Provincial and District Grand Masters shall be empowered to appoint a Provincial or District Deputy Grand Registrar to take rank immediately after the Provincial or District Grand Registrar, Two additional Provincial or District Grand Deacons, Two additional Provincial or District Assistant Grand Directors of Ceremonies, and a Provincial or District Deputy Grand Sword Bearer, and that the Provincial and District Grand Masters be empowered to appoint such additional Provincial or District Grand Officers at the first meeting for the annual appointment of Officers for the several Provincial and District Grand Lodges after the confirmation of the Minutes of Grand Lodge."

The amount of £25 per annum hitherto granted towards the expenses of the Library being found insufficient, the Board recommend Grand Lodge to increase the yearly grant to £50.

Some Provinces, like his own, had such a large number of Lodges that it was After a few words from the Earl of Mount Edgcumbe on the position he took at the last meeting, Brother Eve expressed nimself in favour of theamended recommendation, which was subsequently carried unanimously. Bro. Fenn next proposed the last recommendation of the Board to increase the yearly grant of £25 tovards the expenses of the Library to £50, £25 being found insufficient. He said that the Past Grand Chaplain, the Rev. J. A. Lloyd, at the last Communication suggested that there should be a Grand Librarian. #### OUR FAMILY TREE.

THERE is no doubt the principles on which Freemasonry is based are most admirable, that those principles have been most successfully carried out in all ages and countries, and that they are capable of still further development in the future. But nothing is so calculated to mar the beauty of those principles as the attempts which are continually being made to associate every distinguished man that ever lived, and every noteworthy event that has ever happened since the world was created, with Freemasonry. We have seen it gravely stated that Adam was a Mason, though the native modesty of the writer induced him to refrain from any attempt at solving the knotty question, whether our worthy first parent was initiated before or after he took to wearing an apron of fig-leaves. Noah, the first naval architect, not "arkitect," has been set down as a Mason. The Patriarchs, we believe, are supposed to have been Craftsmen. The two Saints John were Grand Masters, though we have never heard any sufficient reason assigned for the supposition. Euclid was a learned geometrican, and therefore he must have been a Freemason. Pythagoras, who is said to have been, in reality, the author of the famous forty-seventh proposition of the first book of Euclid, was also one of us,—very probably a Past Master of the Craft, as the figure of the said proposition plays a very prominent part in the jewels of Past Masters. A host of celebrities of every age and race are claimed as members of our fraternity. The great reformer, Martin Luther, has been said to have been initiated into our mysteries a short time after he had burnt the Pope's Bull of Excommunication. The most worthy absentee from the roll of worthies is the great Julius Cæsar. We do not remember ever to have seen him described as a Brother by any trustworthy Mason. Possibly, some imperfection disqualified him from participating in the benefits of initiation. Some day this omission may be rectified, or, perchance, in the lapse of time, some brother, more remarkable for his ambition to be enrolled among our Masonic historians, than for the profundity of his wisdom and discretion, may seek to counteract it by the insertion of other distinguished personages—say, for instance, Jonah, or the "Last of the Mohicans." Passing from personages to events, we find the building of the Tower of Babel included as marking one of the earliest epochs in history; but whether or not the first stone was laid with Masonic ceremonial we have never heard. Happily, we are gradually becoming wiser in our generation, and brethren no longer make themselves conspicuous by such exhibitions of ignorance as we have been describing. Still there is even now a great deal of what may be called "sermonising" connected with the Craft, which will convince our readers that the statement is not without some justification. Be it well understood, however, that we have no idea of speaking irreverently of any persons who have been mentioned by name. We are merely desirous of showing how Masonry is affected by the absurd lengths to which such writers go when they give way their imagination.—Chronicle (Sydney).
