FESTIVITIES IN MASONRY.

THE many records we are able to give week by week of social meetings in different parts of the country, at which ladies and Brethren enjoy themselves together at what may be at least described as semi-Masonic gatherings, seem to afford evidence that this feature of Freemasonry, which but a few years back was regarded as an un-Masonic innovation, has not only passed the experimental stage, but is becoming increasingly popular as it becomes better known.

The fact that the majority of the Masonic meetings at which ladies are invited to participate are promoted for the purpose of benefiting one or other of the many Charity funds existing in connection with the Craft, and the known sympathy of the fair sex in all that pertains to the alleviation of suffering and distress, are no doubt the chief causes that lead to so many successes being achieved, and we think the advantage thus aimed at goes far to justify the appearance of the ladies in Freemasonry even in the eyes of those who regard their association with the Craft as out of place and unconstitutional.

But however this may be it is very certain that this season Masonic festivities appear to have been more numerous and more popular than ever, and from the reports published of results arrived at we may look forward to many an orphan, a widow, or a distressed Brother being the richer in consequence. We have always advocated the association of ladies in the beneficent work of Freemasonry, believing that their presence cannot possibly do harm, while their interest in the good cause can and does do good. For this reason we hope the practice of entertaining the ladies at the Lodges at least once a year will extend in our midst, that their sympathy in the sacred cause of Masonic Charity may thus be awakened, and permanent help secured.

SUPREME GRAND CHAPTER.

THE Quarterly Convocation of Supreme Grand Chapter was held on Wednesday evening at Freemasons' Hall. Comp. W. W. B. Beach, M.P., presided, having for his H. the Rev. J. S. Brownrigg, and for his J. Comp. J. Thornhill Morland. Comps. E. Letchworth S.E., Thomas Fenn as S.N., Baron de Ferrieres as P.Soj., G. H. Hopkinson as 1st Asst. Soj., J. E. Le Feuvre as 2nd Asst. Soj., and W. M. Stiles Grand Treasurer were in their respective places. Sir George D. Harris acted for Comp. Robert Grey President of the Committee of General Purposes.

There was a good attendance of Grand and Past Grand Officers, and of representatives of subordinate Chapters.

On the motion of Sir G. D. Harris, seconded by Companion Frank Richardson, Charters were granted for the White Rose of York Chapter, 2491, Sheffield; the Eccentric Chapter, 2488, London; the Fellowship Chapter, 2535, London; the Studholme Brownrigg Chapter, 2421, Amersham; and the Southern Star Chapter, 1158, London. The Charter of the Bulwer Chapter, No. 1068, Cairo, having been destroyed by fire, a Charter of confirmation was granted. Chapter No. 260 was ordered to return its Charter; No. 1537 was ordered to be erased, and No. 171 was ordered to be summoned to show cause why it should not share the same fate. On the motion of Sir G. D. Harris, seconded by Companion Richard Eve, £50 was voted to the Scholarship Fund of the Masonic Boys School.

NEW LODGE AT CHESTER.

DECISION has been come to at Chester to petition for the establishment of a new Lodge, to be called the Travellers' Lodge. There are at present three Lodges in the city—the Cestrian, No. 425; the Independence, No. 721, which is the strongest Lodge in the Province, though it is run very closely by a Birkenhead Lodge; and the Clarence, No. 2386, which is largely a military Lodge. The new Lodge will meet on Saturdays, and consequently will be a convenience to commercial travellers, especially those who are or wish to be Masons. The petition for a Charter will be presented through the Lodge of Independence, and there is every probability that the Lodge will be opened within the next two months by Lord Egerton Prov.G.M., or Sir Horatic Lloyd Deputy Prov.G.M. It is proposed the first Master of the new Lodge shall be Brother W. Peers P.M. 721; the first Senior Warden Brother Thomas Owen 721 and P.M. of the Oswestry Lodge; and the first Junior Warden Bro. Hugh Roberts 425 and P.M. of the Caradoc Lodge, Rhyl. Thirty members have already handed in their names, says the "Liverpool Mercury," and as many more are waiting to be admitted as joining members or initiates.

THE CRAFT IN INDIA.

REVIEWING the "History of Freemasonry on the Coromandel Coast" by the Rev. C. H. Malden Past District Grand Chaplain of Madras, the "Madras Weekly Mail" says: "The number of Lodges now working in the Presidency is twenty-three, numbering some 800 Brethren, in addition to what are called the non-affiliates. We learn with some surprise that the Civil Orphan Asylums in Madras were the outcome of a scheme of Masonic Benevolence initiated by Lodge Perfect Unanimity, and the foundation stone of the building now used as the Industrial School at Black Town was laid by the District Grand Lodge. Mr. Malden, however, has been Chaplain of the Asylum, and ought to know. Other buildings associated with Freemasonry are the Capper House on the Beach, and the building which gave its name to the Pantheon Road. The Craft seems to have flourished in Madras on its own merits, and to have been less dependent than is sometimes found to be the case on great names. We notice, however, what an attraction the Craft has for the legal mind. In fact, it is not long ago since every Judge on the High Court Bench and some nine Districts Judges adorned the District Grand Lodge with their names and occasional presence, whilst at the present moment about thirty eminent lawyers and vakils are members of different Lodges."

"A SPRIG OF ACACIA."

WITH many tokens of esteem, the funeral of Brother John Leonard, R.N., took place on Saturday, at the Plymouth Cemetery. As an active and prominent Freemason, and in his professional career as messman for many years of the Royal Naval Engineers' College, deceased had by his genial manner and sterling qualities won the regard of a very wide circle of friends, and his popularity in both naval and Masonic circles was demonstrated by the large attendance at the funeral. On arrival at the cemetery the cortège proceeded direct to the grave, where the Rev. W. Mantle officiated. At the close of the service Bro. Lord read an address, in which he dwelt on the deceased's estimable personal qualities and services to Masonry, remarking that their hearts went forth to the Almighty in gratitude for having so long spared a life of such noble devotion to Masonry, and of such unselfish zeal for the welfare of others. Like a beacon on a rock-girt shore the light of Freemasonry had shone in their Brother's career, not only warning his Brethren of the shoals and quicksands of life, but in times of trouble and adversity, giving relief in distress. The secrets of their Order were confided to the individual care of every Brother, but its teachings and results could not be kept within the limits of the Brotherhood. In the family circle, in social intercourse, and in the Church itself its influences were felt. Great responsibility, therefore, rested upon the Brethren, not only to avoid the neglect of the active principles of Freemasonry, but above all never to pervert those principles to individual selfishness and pride, but ever to present their system to the world as a beneficent angel of light, robed in charity, and winged with blessing. Subsequently the Brethien present dropped sprigs of acacia into the grave, and the procession re-formed and returned to Stoke.

GOOD RESOLUTIONS.

PVERYBODY knows that about this season of the year good resolutions are in order. Everybody at this time resolves now to do better—to do something that he or she has never done before, or, at least, do it better than heretofore, and as has been frequently and truthfully asserted Masons partake largely of ordinary human nature, they, too, will just about this time resolve to do better for themselves and their respective Lodges, i.e., for Masonry. Here is a good "resolve," which is respectfully and fraternally submitted to everybody, more especially to the new Master; "Lay hands suddenly upon man," by which is meant that however slim the treasury, however great the desire of the new Officers or members for work and for additions to membership, let no man pass our gates without the closest scrutiny and the best assurance that the applicant is a positive man, capable not only of appreciating and enjoying the rights and benefits of the Craft, but also capable and willing to add something to the common stock by his industry, zeal and devotion, capable of being tried as so many have been tried before him, and, like them, giving assurance of not being found wanting. Of men like these, of positive men, of members with zeal, with earnest devotion, with sincere love for the Craft and its good teachings, we cannot have too many within our gates, for they have within themselves the element of strength, and they will lend and contribute a share of their latent force to the Fraternity, and render our Lodges stronger and our meetings more interesting. They will help us in the good work, and not retard our progress. But it behoves all to resolve now to be careful, and admit none but the best material to our Lodges. "Lay hands suddenly upon no man." Be particularly careful whom you propose or whom you admit to our mystic circle; we need careful selection in all our material; let no man enter unless you are personally satisfied as to his fitness and his ability and willingness to do some good, bring something to us for allowing him the privilege of calling himself a Freemason. And resolve further to do some good yourself, attend your Lodge more regularly, "take hold" and work and do. Thus will you, your Lodge, and the Craft at large be benefitted by your good resolution.—" New York Tribune."

CUSTOM OR RIGHT.

THERE is much confusion among Brethren as to the right to visit. It could easily be disposed of in the manner that the historian of Ireland disposes of the description of snakes in the famous chapter, "There are no snakes in Ireland." There is no vested "right" to visit any sister Lodge. The reception of the third degree in a just and duly constituted Lodge of Master Masons and being in good and regular standing in the Craft "qualifies" a Brother to visit any regular Lodge, but as each Lodge is a Masonic family, it has an inherent and indefensible right to conduct its own business, maintain its own harmony in its own way, even to the exclusion of visiting Brethren already seated, to say nothing of those seeking admission. It follows that the admission of visiting Brethren, however worthy and however welcome as a general thing, is, when properly considered, an act of fraternal courtesy, which may be granted or withheld as circumstances may warrant, precisely on the principle that a man's house in his castle, and although courtesy may prompt him to answer the door-bell, he will exercise his rights in admitting or refusing an intending visitor, and this is exactly the case with every Master Mason-he may ring the door-bell, that is, he may ask to be admitted to any Lodge, but every member of that Lodge, of that particular Masonic household, has the undeniable privilege to refuse admittance, and the applicant's "rights" close then and there. There is absolutely no "right" in this matter whatever.

And now as to the alleged right to examine the Charter of a Lodge a Brother desires to visit. The visitor asks the privilege of joining in the labour of a Lodge. He practically says: "I propose to myself the pleasure of visiting you this evening, but before introducing myself to you, be good enough to exhibit the authority by which you are now here assembled." Just as if some one coming to visit your home should demand an examination of the deed or lease by which you hold it, or your visitor, before taking a seat in your parlour, should demand the "right" to see your receipt for last month's rent. How many of those who demand to see the Charter of your Lodge are competent to

judge as to its regularity or genuineness?

If the reader will endeavour to measure in his own mind the competency of the Brotherhood generally, including, as it does, all grades of intelligence, to pass upon the validity of a document submitted for cursory examination, he will be able to form some idea of the absurdity of the whole proceeding. Most certainly very many of these Charters are old, dilapidated, often illegible by long service, the old-fashioned wax seals "gone and

forgotten," the signatures are faded and sometimes even obliterated. Who can judge of its being a just and legal document, issued by the Competent Authority of, &c. Masonry can do a great deal for man in the way of moral instruction and strong incentives to a virtuous and upright life, but it cannot give him powers God and Nature have denied him, hence the examination of the Warrant is as near an absurdity as anything can be, and furthermore it is the business of a visitor to know in advance that the body he proposes to attend is genuine, and not depend on wits or a skill he may not possess to discover the fact. Warrants are the outcome of our present Grand Lodge system, hence their use must be governed by the regulations made by the several and respective governing bodies, among which none should be found to require the exhibition of the Charter to any or all who may wish to look at it without having the slightest method or knowledge to prove its validity. Let this nonsense be abandoned and abolished altogether. When the Grand Lodge shall meet at its next regular annual convention the revision of the constitution will be brought before the governing body, and this will be an excellent chance to weed out many of these silly proceedings which have from time to time crept in, and have been allowed to remain without rhyme or season. The "right" to visit is stated distinctly enough; let this "right" of examining the Charter be "distinctly" done away with.—"New York

In Lodges where there is a multiplicity of offices there is frequently a lack of a sufficient number of jewels, and the installing Officer usually passes over the omission as best he can. The fact remains, however, that regarding the ancient significance of "Investiture," an Officer, whether in a subordinate or in a senior position, is not truly qualified until he has been officially invested with the symbol of the office to which he has been elected, and its symbolical meaning explained illustrative of his duties. The investiture of an Officer is no less important than the investiture of a candidate.—"Mallet," in "Glasgow Evening News."

Since the fund was started in 1864 £10,138 has been received, and £4,651 has been disbursed, including only £423 for the expenses of management, printing, &c., for all that period. All the thirty Lodges are represented in the subscription list for 1895, the highest this year being No. 589 (Redruth), with £20 5s. The report is full of information respecting the fund. The Officers are:—Bros. E. M. Milford, Treasurer; Edward D. Anderton, Secretary; and James C. R. Crewes, Assistant Secretary.—"Western Morning News."

MEDIÆVAL FREEMASONRY.

No architect of the present day is fettered by any other rules or conditions than those imposed by his employers in regard to the choice of a style. He may copy that of any nation and any period, and he may alter, combine, detract from or add to it, as he pleases. Indeed, he must do so more or less, because no one recognised and distinctive national architecture either ecclesiastical or secular, exists at the present day. It is all copied, and none of it is, properly speaking, original or self-developed. It has ceased to be inventive, at least in any favourable sense. But the case was very different in the Middle Ages, when Freemasonry was a Craft in the hands of a corporate ecclesiastical confraternity, the members of which seem to have been bound down to certain rules and yet to have had almost unlimited license in carrying those rules into effect; precisely in the same way as if the alphabet of a language were given to any one, and he were allowed to combine the letters into words as he pleased, but not to introduce any new forms or symbols. This seems exactly to illustrate the position in which the ancient Freemasons stood. They had certain kinds of mouldings, foliage, window tracery, &c., which were, with comparatively trifling modifications and exceptions, repeated in all buildings of the same era, only very arbitrarily combined, arranged, or applied. For example, in the age of the complete Gothic or Flowing Decorated all window tracery was designed on one fixed principle; it was neither geometric nor rigidly vertical, as in the next style, but it was, with surprisingly few exceptions, of wavy and curved lines. Yet each architect seems to have had full liberty to adapt this principle to his own taste, and thus we find thousands of different patterns. Again in mouldings; some ten or a dozen forms being employed by all with inflexible exactitude, their grouping, or positions in relation to each other, as well as their application, seems to have been the result of individual caprice. And herein is the glory of the Gothic styles, that they attained by these means perfect uniformity combined with almost infinite variety. There is no monotony, no wearisome repetition; every detail has some freshness, yet all are strictly subjected to certain laws of composition. Hence that charm of never-ceasing interest created by perpetual novelty; for this in reality is a much more enduring gratification than either the magnificent effect or the exceeding aggregrate beauty of some buildings, both which impressions are rather those of first sight, while the minute detail of any one building might engage the attention for months, or even years. Little or nothing h transpired of the secret system which the Freemasons adopted in building, nor of the organisation of their body, except that it was ccclesiastical and under the jurisdiction and benediction of the Pope. It is certain that they were a very numerous, energetic and talented class, whose genius was chastened and ennobled by all the enthusiasm of a grand religion, and whose efforts were aided by the supply of almost unlimited resources. They must have had the entire monopoly of both domestic and ecclesiastical architecture, though perhaps the distinction is vain, for everything in the Middle Ages was ecclesiastical.—"Builders Reporter."


