# SOUTHAMPTON CHARITY.

IN connection with the approaching 103rd Festival of the Royal Masonic Institution for Boys, at which the Grand Master of the Province of Hampshire and the Isle of Wight is to preside, a banquet was held at the South Western Hotel, Southampton, on Thursday, 16th ult., which was attended by over 100 Brethren representing the six Lodges in the Southampton district. Bro. G. J. Tilling P.G. Deacon Eng. presided, and the Vice-Chairs were occupied by Brothers Bagshaw W.M. Gloucester Lodge, Lovell Stevens W.M. Lodge of Peace and Harmony, W. J. Berry W.M. Southampton Lodge, S. Cooksey P.M. Shirley Lodge, J. Methven P.M. and Sec. Clausentum Lodge, and R. W. Denness P.M. Albert Edward Lodge. The guests of the evening were Bros. E. Goble P.G.S.B. Eng. Deputy Provincial Grand Master, and J. M. McLeod Secretary of the Boys School. A recherché banquet was served by Bro. Kuntze, manager of the Hotel, and during the repast choice selections of solo and concerted music were performed.

Dinner over, the Chairman proposed the King and the Craft, which was followed by other Masonic toasts, the Chairman responding for Grand Lodge Officers, Bros. Goble and McLeod also rising.

The last named proposed the Provincial toast, specially referring to the high esteem in which the Provincial Grand Master Bro. Beach was held by Masons everywhere, and urging that the Brethren of his Province should make the coming Festival a record in the career of their chief.

The D.P.G.M., with whom rose several past and present Provincial Grand Officers, responded, and cordially endorsed the remarks of Bro. McLeod concerning the Provincial Grand Master, and then congratulated the promoters of the gathering on the success which had attended their effort, which he hoped would result in a banquet in aid of the great Masonic Charities being held annually in Southampton, and that the example set that night would be followed by other towns in the Province.

Bro. Lemon proposed the Masonic Charities, and said that gathering was unique in the history of Southampton Freemasonry, and he, too, hoped it would be made an annual affair.

Bro. McLeod made an eloquent response, in which he dwelt more particularly upon the Institution with which he

is immediately connected, referring to the excellent training the boys received, and to the educational successes they gained in examinations. He further stated that thirteen lads from the Province of Hampshire and the Isle of Wight were being educated in the School.

A feature of the evening, which excited great interest, was a ballot for life-votes for the School, and an "auction" by Bro. Sawbridge of similar votes, the approximate result being announced at £152 5s, which will be placed on the lists of certain Stewards attending the Festival, in the names of the Brethren who were successful in the pallot or purchased the votes "under the hammer."

An excellent musical programme was gone through under the direction of Bro. G. Leake, Mus. Bac.

### EAST LANCASHIRE.

THE annual meeting of this Provincial Grand Lodge was held on Wednesday afternoon, 15th ult., at the Belgrave Schools, Darwen. As no gathering of the kind had been held in the town since 1875, the function was of special local interest, and the attendance of Brethren attached to Lodges in the surrounding district was very large. All the Lodges in the Province were represented, numbering 113.

Lord Stanley, M.P., was unable to take the chair as Provincial Grand Master. His Lordship had been expected to attend, and the occasion had been looked forward to as affording an opportunity for the Brethren to give their ruler in the Craft a cordial welcome to the Province after his return from South Africa. Lord Stanley was installed in return from South Africa. office in November 1899, at the Free Trade Hall, Manchester, in succession to the lamented Colonel Starkie. Afterwards he went to the war with Lord Roberts as press censor, and since then he has been unable to meet the Brethren of the Province. His visit to Darwen was regarded as a certainty until a day or two ago, when Lord Stanley wrote to the Provincial Grand Secretary expressing sorrow for his compulsory absence, but explaining that the discussion of the Army Scheme made it imperative that he should be in his place in Parliament.

In the regretted absence of the head of the Province, the next in command, Bro. C. R. N. Beswicke-Royds Deputy Provincial Grand Master, presided. Bro. Forrest Past Prov. G. Warden acted as Deputy Provincial Grand Master, and Bros. C. D. Cheetham and G. Norris Midwood were in their chairs as Provincial Senior and Junior Wardens respectively.

Bro. J. H. Heap Prov. Grand Treasurer presented his accounts for the year ended 31st March. The statements showed that £1,064 had been received from all sources, and that a balance of £218 remained in the bank. This balance he explained was £48 less than was the case a year ago, but it was more than accounted for by the payment of fifty guineas, in accordance with the resolution of Provincial Grand Lodge, to the South African Masonic Relief Fund. On the motion of Bro. W. E. Clegg, seconded by Bro. Archie C. Wilson, two of the Auditors, the balance-sheet was approved.

The Provincial Senior Grand Warden, in moving the adoption of the Charity Committee's report, urged the representatives of several Lodges to use despatch in sending up their votes for the forthcoming election of Annuitants upon the funds of the Royal Masonic Benevolent Institution for Freemasons and the Widows of Freemasons. There were two candidates from the Province, an old man and an old widow, and all votes were needed. On behalf of Captain John Barlow, he thanked all the Brethren who went to London in March to vote for that Brother as a candidate for the Grand

Treasurership. He questioned whether any Brother in England could have attracted so many Brethren as those who went from the Provinces of East and West Lancashire, Cheshire, and West Yorkshire to spend their time and money and effort to do honour to him. He hoped that Captain Barlow would be a candidate for the Grand Treasurership next year, in which case he believed there would be no contest. If a contest was again necessary, however, all who recently supported him would do so again, and would obtain for him so many other votes as would secure his election. Bro. W. Goldthorpe P.Prov.G. Registrar seconded the motion, and it was adopted.

The Senior Grand Warden afterwards made an earnest appeal on behalf of the Festival which is to be held at the Royal Botanical Gardens, Old Trafford, next month, in aid of the East Lancashire Systematic Masonic Benevolent and Educational Institution. By their first Festival, in 1805, he said, a sum of about £4,450 was raised, but that amount it was estimated would be exceeded by some thousands of pounds. The degree of enthusiasm displayed in the undertaking was something which had never been equalled in the Province. Every Lodge was contributing most handsomely towards the Festival, every Provincial Grand Officer would, it was thought, qualify himself as a Life Governor of the Institution. There were more than three Lodges at present with over twenty Stewards each, all of whom would qualify as Life Governors, and it was probable that the total financial result of the Festival would be a sum that would astound their own and other Provinces. He moved that £100 be voted from the funds of the Lodge to the Festival. Captain Barlow seconded the motion, and it was carried.

Bro. Thos. Duxbury moved, Captain Barlow seconded, and the Acting Deputy Provincial Grand Master supported, the election of Bro. James Aspden, Harmony and Industry Lodge, No. 381, Darwen, as Treasurer; Bro. Israel Greenhalgh nominated, and Brother Kenyon P.G.Std.B. England seconded, Bro. Holgate, St. John Lodge, No. 348, Bolton. The Darwen candidate was elected by an overwhelming

The Acting Provincial Grand Master, in the name of the Lodge, congratulated Bro. Cheetham upon having been appointed a Grand Deacon of England. Hearty applause was evoked by the well-deserved compliment.

THE annual convocation of this Provincial Grand Lodge of Mark Masons was held, at the invitation of the Star in the East Lodge, at Scarborough, on Tuesday, 21st ult., Lord Bolton Prov.G.M.M. presiding. The Brethren assembled in the Masonic Hall, St. Nicholas Cliff.

WE are often reminded that Bournemouth is, above all else, a Victorian town, and that we can show our visitors few "ancient landmarks" like those which are the chief glory of such resorts say, as Bath or Hastings. It is true that the immediate vicinity of our "Evergreen Valley" abounds in places associated with the most fascinating epochs of English history and tradition, of which the New Forest, Corfe Castle, Christchurch Priory, Hengistbury Head, and Wimborne Minster are but a few. Still, the fact remains that, so far as the town of Bournemouth is concerned—its public buildings and institutions—we are of mushroom growth compared with other towns of similar area and population.

We have, however, in our midst one institution at least which has attained to something like a respectable age. We refer to the Hengist Lodge of Freemasons, which, established in 1770, was transplanted from Christchurch on 9th May 1851, and attained its Jubilee on Thursday last. There has been no great festive celebration of the event; but it was, no doubt, made the occasion of felicitation at the last

meeting of the Lodge; and is one of interest to the general body of townsmen outside the ranks of the Masonic Craft. A brief reference to the Lodge's growth and development will not therefore be out of place. The history of the Lodge was fully chronicled by Bro. C. J. Whitting during his Mastership in 1897, and referring to the pages of that interesting volume, we note that as far back as the 24th June 1841 there was a Masonic gathering at the Bell Vue Hotel, members of the Hengist Lodge assembling with a number of Brethren from Poole to celebrate the anniversary of St. John. Ten years later there was another meeting at the Belle Vue. The Lodge had been in a condition of "suspended animation," but the sanction of the Provincial Grand Master Admiral Sir Lucius Curtis, Bart., was obtained for its revival and transference to Bournemouth, and in the words of the historian, "it emerged from obscuration," entered upon a new career which, practically speaking, has been one of uninterrupted prosperity. Of those who were present at that revival only two Brethren now survive—Bro. D. Sydenham and Bro. G. H. Gutch (of Poole). The oldest member of the Lodge, however, is Bro. J. Druitt, sen., of Christchurch, who was initiated in 1839, occupied the chair in 1844 and 1845, and is the only surviving link with the old days at Christchurch. There are surely few Masons living whose connection with one Lodge extends over so long a period! Bro. Druitt certainly has no rival in Hengist Lodge, for next on the roll of seniority is Bro. W. B. Rogers, whose admission was seventeen years later. initiate in Bournemouth was the late Bro. W. E. Rebbeck, and the roll of members includes most of the names that will be best remembered as pioneers of local prosperity. The last Mason initiated in Christchurch was the grandfather of the present Earl of Malmesbury, who was himself the first candidate to join the Lodge in the new century a few months ago. This is apparently characteristic of the membership, that successive generations of families become Brethren of the Mother Lodge, as the same surnames frequently occur among the many hundreds in the roll which forms a valuable appendix to the volume referred to above.

The Lodge of Hengist, we may add, is now the proud mother of two vigorous daughters in Lodge Boscombe and Lodge Horsa, and a third off-shoot is a practical certainty There is room, no doubt, for yet another of the near future. Lodge-and work for it to do when established. In the past there have been occasions when Freemasonry has been suspect by the ruling powers—especially on the continent of Europe—but in this country its activities have been largely restricted to social and charitable channels, and at the present time its unobtrusive benevolence is generally recognised. Here in Bournemouth, the rare occasions when the Brethren have allowed the general public to witness any portion of their quaint and picturesque ceremonial have invariably been in connection with the building of churches or hospitals, an association which has been of appreciable value to the works thus assisted, and has secured for the Craft the goodwill of many who have no personal knowledge of its mysteries, and are content to judge of its worth by its work. All such, we are sure, will join with us in heartily congratulating the Bournemouth Freemasons upon the attainment of their Jubilee, and trust that when they celebrate their Centenary in the borough (an epoch which, as a Lodge, was duly honoured over thirty years ago) they will more than ever be distinguished for promoting human Brotherhood and good works.—" Bournemouth Visitors' Directory."

# ALBANY LODGE CENTENARY.

THE Albany Lodge, No. 151, this year completed the hundredth year of its establishment and continuous existence at Newport, Isle of Wight, and the auspicious event was naturally regarded as one of special importance in the annals of local Freemasonry.

The celebration of the Centenary on Tuesday, 7th ult, was attended by a large gathering from all parts of the Province of Hampshire and the Isle of Wight and from other places. The proceedings took the form of a luncheon at the Masonic Hall, followed by a public Service at the Parish Church, attended by Masons in procession in full regalia, and the presentation of a Centenary Warrant at a special Lodge, which in order to accommodate those present had to be held in the large room of the Star Hotel, the whole being brought to a conclusion after tea at the Masonic Hall with a very enjoyable variety concert in the banqueting room.

It was hoped that the venerable and highly esteemed Grand Master of the Province of Hampshire and the Isle of Wight, the Right Hon. W. W. B. Beach, M.P., would have been able to fulfil his intention of being present, but he was at the last moment detained by an urgent Parliamentary whip. His duty was ably discharged by the Deputy Provincial Grand Master Bro. Edgar Goble P.G.S.B. Eng.

The luncheon, with which the proceedings commenced at 1.15 p.m., was attended by some seventy Brethren, over whom the W.M. of the Albany Lodge Bro. E. F. King presided. Before proceeding with the short toast list which had been arranged, the W.M. made a brief reference to the importance of the event which had brought them together that day—the celebration of the Centenary of the Albany Lodge—and said that though pressure of time prevented his then touching upon the various matters in connection with the auspicious event for which opportunity would occur later in the day, he could not pass on without extending a hearty welcome to all who were there and thanking them for their presence and support on that occasion.

The W.M. then submitted the toast of the King and the Craft, remarking that His Gracious Majesty, the Patron and long the Grand Master of the Order, had given his promise to devote his life to the welfare of the nation, and they had every confidence that he would prove a worthy successor to his illustrious mother.

In proposing the P.G.M. of Hampshire and the Isle of Wight the Right Hon. W. W. B. Beach, M.P., the W.M. said that no one in the kingdom had worked harder, more zealously, or more faithfully for Masonry than their revered Provincial Grand Master had done, and they had good cause to rejoice that in him they had one placed over them whose neart was right and whose conduct was just, and might he be blessed with health and strength for many years to come to carry on his good work for the benefit of the Craft in general and that Province in particular.

The W.M. also proposed the D.P.G.M. Bro. E. Goble P.G.S.B. Eng., and the Officers of Prov. Grand Lodge present and past, expressing the pleasure and satisfaction the members of Albany Lodge felt at the presence of Bro. Goble (who had done such splendid work as Prov.G.Sec. for so many years) and of so many of the Officers of P.G. Lodge.

Bro. Goble responded, giving expression to the regret the Prov.G.M. felt at being unable to be with them that day, and offering his hearty congratulations on the occasion they were met to celebrate.

The visitors were formally welcomed in a cordial speech by Bro. J. G. Pinnock, and Bro. Greenham, of Shanklin, responded in a genial and fluent speech.

The last toast, the Worshipful Master of Albany Lodge Bro. E. F. King, was proposed by the D.P.G.M. Bro. Goble, who warmly congratulated the W.M. on the excellence of the arrangements made by the Lodge that day and for the hospitality extended to the Officers of Prov. Grand Lodge.

In response the W.M. said he knew that the honour done him had been because he represented the Lodge, and he should ever look back upon that memorable day as one of the happiest and brightest in his life. For the success of the arrangements he was indebted to members of the Lodge for the kind co-operation and loyal support they had given him, and he desired particularly to mention the valued assistance given by the two Hon. Secretaries Bros. Horan and Hutton.

At 2.45 the Brethren, joined by others who had by this

time arrived, formed in procession to proceed to St. Thomas's Church for Divine Service. The Provincial Grand Officers came last with the officiating clergy, conspicuous among the latter being the special preacher of the day, the Rev. F. M. Burton, LL.D., Past Grand Chaplain of England, who wore

the brilliant scarlet rope and cap and the ermine cape of his degree of Doctor of Laws of Cambridge University.

Founding an impressive address on the text "And now abideth faith, hope, and charity, these three; but the greatest of these is charity," the Rev. Dr. Burton, addressing those before him as "Worshipful Masters and well-beloved Brethren," said it gave him the greatest possible pleasure to stand in that place, to which he was accustomed for about eight of the best years of his life, and to face them upon that great and auspicuous occasion. It was a great occasion in the annals of Freemasonry, and particularly in the annals of the Albany Lodge, about which he had intended to say something, but which he would be very brief about, because they would be able to read for themselves in the admirably prepared pamphlet which he had seen, the history of the Albany Lodge.

It was a very old Lodge indeed, and it came from Salisbury, in Wiltshire, its Charter bearing the date of the 9th of July 1777, and therefore it went back further than a century. It was quite one of the ancient Lodges. would probably recollect that in 1799 an Act of Parliament was passed for the suppression of secret societies, and the Freemasons evaded, should he say, that Act by determining to create no new Lodges in the sense of granting new Charters, but applied for the old Charters of Lodges which for one cause or another became defunct and used them for other Lodges, and so the Charter of the Albany Lodge was the old Charter of the Salisbury Lodge. They were dealing with the history of 100 years, of the nineteenth century, and to those who might be detractors of Freemasonry -and there were many-he would say "Be careful what you

do or say.'

If they believed, and if they were Christian men they did believe, that the Almighty ruled all things, did they suppose for one solitary second that the Almighty, who was all powerful, would have permitted to continue and flourish in the midst of that mighty Empire to which He had entrusted so much of the surface of the globe and so much of the civilisation of the world, an organisation which was iniquitous and wrong? Oh, no! They must remember they had to deal with one, "Di hou ta panta, Kai di ou ta panta," on whose account and by whose means all things exist, and He had blessed that organisation of Freemasonry. Their presence in that church that day was a direct proof of it. So he would say to the detractors of Freemasonry outside the walls of the church: Let them beware. This thing is of God, or else how is it it has not fallen long ago!"

What a glorious thing it was to be a Mason. Masonry was not religion, nor was it a substitute for religion; but it was, or should be, a handmaid to religion, to lead them on step by step to higher things, upward and onward. Excelsior should be their motto. Had the Albany Lodge, No. 151, done any good work in the past? Right heartily and gladly they said "Yes." Then let "Excelsior" be their motto still. Let it go on—that Lodge at Newport, which he knew had done so much good—let it flourish and abound more and more. Masons, of all men, should best understand that God seeth not as men see. God looketh at the heart, and did all Masons thus know God and act accordingly? Did they ever so far forget themselves as to take God's holy name in vain? Did they always remember the Sabbath-day to keep it holy? That was true Masonry. Did they ever act like those who said "Tush, how doth God know?" Well, he ventured to leave those questions with them.

It was a fearful thing to be celebrating that Centenary unless that true Masonry, that true building and edifying, was going on in that and every Lodge, from the Grand Lodge, which he represented, down to the humblest little Lodge now starting. An unworthy Mason was a man devoid of principle. The tongue of good report was demanded on behalf of the humblest of their Brothers, or how would it be with them when they stood before the Great Architect of the Universe and demanded admission into the Grand Lodge above? Faith, hope, and charity—that was true Masonry. The Masons of England, they were proud to know, had done much which

might meet the eye of the outside world, in building and restoring the Houses of the Great Architect of the Universe. He need only mention that in connection with the reredos of Gloucester Cathedral and that great work done upon that national monument of beauty and antiquity, Tewkesbury Then there were the large contributions made for the relief of the suffering in connection with the Indian Famine and the contribution to the National Lifeboat Institution in 1875 as a thank-offering for the safe return from his Indian tour of their Gracious King and Patron, whom

might God long preserve and protect.

The excellencies of Freemasonry they knew better than he did, and he hoped practiced them more. Theirs was one of the most evangelical societies he knew, and guided by the Volume of Sacred Laws, the Bible, it inculcated duty towards God and their neighbour. It also came close home to the man and reminded him he was not a true Mason unless he did his duty to himself by doing all he could to preserve his faculties, his mind, body, and soul in the most efficient condition to serve God always and his neighbour as himself. To the citizen it said "Honour all men, love the brotherhood, fear God, honour the King," and the individual it helped to practice every domestic virtue as well as public virtue—to be a good father, good brother, good son, and also to practice such virtues as prudence, temperance, fortitude, justice, and fidelity in ways some of which he could not mention; but others were public and patent in the lives of his Brethren before him. It taught obedience. Disobedience was the root sin of all-

. . . man's first disobedience and the fruit Of that forbidden tree, whose mortal taste Brought death into the world and all our woe, With loss of Eden, till one greater Man Restore us and regain the blissful seat."

Freemasonry practiced Charity, which had the approbation of Heaven above and, like its sister Mercy, blessed him who gave as well as him who received. For instance, at the Boys Centenary in 1898, under the presidency of their most noble and august Grand Master the Prince of Wales, £141,000 was brought together for educating the youth of this country. They were a great savings bank, so to speak, and they helped the nation to educate the youth of the nation and to care for it and train it. He believed that taking the average, when there was no Centenary and no unusual event, £50,000 a year was raised and spent in education and what might be called old-age pensions by that mighty body of which they were members. In conclusion he exhorted them to remember that

"More things are wrought by prayer
Than this world dreams of. Wherefore, let thy voice
Rise like a fountain for me night and day.
For what are men better than sheep or goats
That nourish a blind life within the brain,
If, knowing God, they lift not hands of prayer
Both for themselves and those who call them friend.
For so the whole round earth is every way
Bound by gold chains about the feet of God."

A collection taken in church by Past Masters of the Albany Lodge on behalf of the Masonic Charities amounted to £10 ε3.

As the accommodation was insufficient at the Masonic Hall for the numbers attending, permission was obtained for the holding of the Lodge in the large room at the Star Hotel, where the Brethren assembled on their return from church, the Provincial Officers entering in procession, and

being received in due form.

The opening business having been disposed of, the W.M. again expressed the pleasure the members of Albany Lodge felt at the presence and support that day of so many visiting Brethren. They had felt that the most appropriate thing they could do themselves in celebration of the Centenary was to raise a special fund for the reduction of the debt remaining on their Lodge building, and he had much pleasure in announcing that £205 had already been raised in this way. This amount was likely to be considerably increased, as several had not yet decided how much they would give. Having thanked the members for their liberality, the W.M. called upon Bro. Frank King to read a brief historical sketch of the Lodge, which that Brother had compiled from the records. A copy of this interesting historical sketch, reference to which appears elsewhere, was presented to each Brother in attendance,

The W.M. heartily thanked Bro. F. King for his admirable sketch and for the pains which he had devoted to its production in such an attractive and entertaining form. Alluding to the statement in the sketch that Sandown and Chine Lodges were off-shoots from Albany, he said the old Lodge was proud of its connection with such eminently capable Lodges, and they looked forward with equal pleasure and hope to the success of the Needles Lodge, now about

to be formed in the same way, at Freshwater.

The D.P.G.M. then rose to present the Centenary Warrant to the Lodge, and after complimenting Bro. F. King on his historical sketch said there were two events of special importance in the Masonic career of a Provincial Grand Master—the Consecration of a new Lodge and the celebration of the Centenary of a Lodge which had come to that distinction. They could understand how greatly their Prov.G.M. regretted that he could not attend that day. He would expect from him, his Deputy, a very particular account of the proceedings, and he was glad to tell them he should have to give him a very complimentary report of the excellent arrangements made and of the admirable manner in which the work was carried out there, and he could assure them the Prov.G.M. would very much appreciate it, as he did all good Masonic work in the Province. In the course of a brief sketch of Masonry in this country, touching on the formation of Grand Lodge in 1717, the temporary separation of "Antients," and the re-formation of Grand Lodge on its present basis in 1813, the D.P.G.M. said Albany was one of the few existing Lodges formed under the "Atholl" Warrant. There was a great source of satisfaction for them to look back upon in the benefits which had accrued during the last 100 years to the numerous Brethren who must have been connected with it in the course of that period. The Centenary Warrant which he had the pleasure to bestow on them on behalf of the Prov.G.M. would entitle the members to wear a Centenary jewel so long as they were connected with the Lodge, and he sincerely trusted it would inaugurate a further long period of good work faithfully done.

The W.M. thanked the D.P.G.M. on behalf of the Lodge for the presentation and for his admirable address. That was a red-letter day in the annals of the Lodge and a landmark in their history. It was a time to recall the blessings of the past, to take stock of the present, and from which to go forward with encouragement, with satisfaction, and with hope for the future. Referring to the service at the Parish Church that day the W.M. said no one could fail to be deeply impressed with the exceptional sermon it had been their privilege to listen to, the words of which would continue in their minds long after that function had passed away. the course of a complimentary reference to Bro. F. King's historical work, the W.M. dwelt on the indebtedness of the Lodge to the three names therein singled out for the good work they had done—the late Bro. Wyatt, whose name was still dearly cherished; Bro. Allée, the father of the Lodge, who could boast a Masonic record of forty years faithful and zealous discharge of duties; and Bro. Pring, who had succeeded Bro. Wyatt as Treasurer, and had carried out the duties for the last twenty-two years in such a manner as to win the regard and affection of every member. He concluded by again thanking the D.P.G.M. for his presentation of the Warrant, which would have a far-reaching influence on the Lodge and be cherished as a priceless heritage.

Bro. Pring moved that the best thanks of Albany Lodge be given to the D.P.G.M. Bro. E. Goble and the Officers of Provincial Grand Lodge for their presence on the occasion of the celebration of the Centenary of the Lodge, the proposer remarking that it gave them all much pleasure to see Bro. Goble in such good health again. Bro. Dr. Coombs seconded, saying that in the absence of the Prov.G.M. no Brother could be more welcome for the duty he had so well discharged than one who had devoted himself to Masonic work with such self-denying zeal as Bro. Goble had done.

In proposing "that the warmest thanks of the Lodge be tendered to Bro. Rev. F. M. Burton P.G.Chap. Eng., for the honour of his presence and for his able discourse in St. Thomas's Church," Bro. G. A. Brannon spoke of the particular pleasure it had been to those to whom Bro. Dr. Burton had become endeared by association in the past to watch his rise to the high Masonic rank he had attained,

and of the great gratification it was to the whole of the Lodge that one of their own former members so distinguished and so esteemed should have been willing at considerable inconvenience to take the part he had done in the day's proceedings. He also desired to thank their Brother the Vicar and Bros. the Rev. P. G. U. Pickering and the Rev. A. T. Richardson for the help they had given. Bro. F. King briefly seconded, reminding the Brethren that Bro. Dr. Burton was initiated into Masonry in Albany Lodge. Both propositions were carried with acclamation.

A "high tea" was afterwards held at the Masonic Hall, and the remainder of the evening was spent in harmony, the pleasure of which was much enhanced by excellent glees and solos, kindly given by the Vectis Glee Singers, consisting of Messrs. Brummell, Denham, Osborn, Orchard, and D'Anna, who were warmly thanked by the W.M. for their much appreciated efforts.—"Isle of Wight County Press."

The annual ball of the Smyth Lodge, No. 2284, of which Bro. G. W. Goddard is the present Master, came off on Friday, 3rd ult., at the Town Hall, Grimsby. Like the majority of the annual social functions this event had been postponed on account of the lamented death of Her Majesty Queen Victoria, and although postponed balls are looked upon as a rule as shorn of success, this can scarcely apply to that of the Smyth, for the details were carried out with all the elaboration characteristic of this ball, the dancing and the supper were as enjoyable as heretofore, and the guests were as numerous as could possibly have been anticipated, over one hundred being present. Undoubtedly this measure of success was due to the individual efforts of the Officers and Committee.

At the last meeting for the present Masonic year of the Æsculapius Lodge, No. 2410, held at the Hotel Cecil, Strand, Bro. Ernest Clarke, M.D. Lond., F.R.C.S. Eng., was unanimously elected Worshipful Master for the ensuing year. Bro. G. Danford Thomas, M.D. Brux., Coroner for London and Middlesex, was re-elected Treasurer.



# MASONIC CONVERSAZIONE.

BRETHREN of the Devon Lodge, No. 1138, Newton Abbot, lately held a most enjoyable conversazione in the Masonic Hall. It was under the patrogage of the Acting Provincial Grand Master of Devonshire Bro. Major G. C. Davie P.G.D. Eng., Bro. the Right Hon. Earl of Halsbury, Lord Chancellor, P.G. Warden Eng., and the best known West-country Masons. The arrangements were in every way admirable, as they always are at Newton Abbot, and the programme was carried through with much spirit. There was a large attendance of Brethren and lady friends from the town and district. The proceeds were to go to the provision of curtains for the W.M.'s chair, the surplus to be applied to the Devon Aged Widow Fund. Proceedings commenced as early as 6.30, with a lecture on the "Old Charges" of the Cathedral builders in relation to the Free and Accepted Masons of Great Britain and Ireland from 1300 to 1900. It was delivered by Bro. W. J. Hughan, of Torquay, P.S.G.D. of England P.S.G.W. of Egypt P.Prov.G. Secretary and P.P.S.G.W. of Cornwall. The lecture had special reference to the continuity of Freemasonry during the last five centuries, and was illustrated by a number of facsimilies of old charges dating from the fourteenth century. Some of these were in book form, while others were in rolls, as originally used by the building Fraternity. Bro. Hughan stated that when he began the study of these curious MSS., nearly forty years ago, there were only about a dozen copies known to be in existence. Since then, with the aid of other diligent students, he had traced something like seventy of them. All of them

had been reproduced, and more than half he had copied. The oldest minutes known were dated 1599. date to the present time there was abundant evidence of the activity of Lodges, either under Grand Lodges or working separately. The Grand Lodge of England, which was the oldest, largest, and most charitable under the sun, had been in existence nearly 200 years. Until recently it was presided over by his Majesty the King, who, since his accession to the throne, had graciously consented to become Protector. His Majesty had been succeeded by his brother, the Duke of Connaught, who was to be installed in the third week in July in the Royal Albert Hall, London. Brother Hughan mentioned that that morning he received information that his Majesty had accepted a copy of the latest reproduction of one of the old charges recently discovered. In an anteroom there was an interesting exhibition of Masonic curios, lent by Bro. F. J. W. Crowe, of Torquay. The exhibits included a collection of jewels, aprons, and diplomas. Some of the aprons were extremely elaborate and curious, having been collected from all parts of the world. The collection of diplomas was also very fine, this branch of research being one in which Bro. Crowe holds a unique position, no other collection in the world being so complete. A concert followed the lecture, and dancing succeeded.

# CHURCH SERVICE.

A SPECIAL Masonic Service was held on the 12th ult., in Clontarf Parish Church, and was largely attended by members of the various local Lodges. Full regalia was worn.

The preacher was the Lord Bishop of Down and Connor, who founded his sermon on some verses from the 133rd Psalm, commencing "Behold, how good and how pleasant it is for brethren to dwell together in unity. At the end of At the end of an impressive sermon His Grace said he was addressing that evening a body of men who might be described by the very words of the text. They knew each other as Brothers. They were bound together in bonds of amity and love. The Confraternity exercised great gifts of charity. But it did not recommend itself so much to him on that account as that it took away prejudice; it took away the barriers which rose between man and man; it brought men together. The teaching of the Confraternity was that all mankind was one. It taught its members to do good in the world. Such a body was greatly to be admired and encouraged. Its members were not taught to cast aside any convictions that they held in their hearts as regarded religion or anything else. But they were all to be ready to hold forth a helping hand to a Brother, to assist him in his necessity, and at all times show him their goodwill and affection.

What he wished specially to refer to was the assistance given to distressed Brother Masons and to Widows and Orphans. In the year that our late beloved Queen celebrated the Jubilee of her reign, the Victoria Jubilee Fund was founded as a memorial of that happy circumstance, and it had been increasing in success year by year, till at present he believed its income was £750. There were twenty-seven annuitants on the roll, half being Brothers and the other half being Widows of deceased Brothers. He very earnestly appealed to the congregation to give their help on such an occasion. He prayed that the spirit of heavenly love might descend upon every heart, that everyone might exhibit that which was so precious and beautiful in the sight of God, that there might be amongst them all that Brotherly unity for which we were created by the Almighty hand of God.

The collection was taken up in aid of the fund mentioned by the preacher, his appeal being most generously responded to by those present.

"M.A.P.," referring to the proposed nomination of Bro. F. G. Ivey for the position of Grand Treasurer of the Mark Degree, says that Brother is well-known in mercantile circles as a recognised authority on all matters connected with the coffee industry—a branch of commerce with which he has been associated for upwards of thirty years. He will be remembered as having rendered a most important service to British importers some few years since by a visit of inspection to the chief coffee-growing centres of the world, a visit fraught with the most valuable results alike to buyers and consumers of "the aromatic berry," as reporters would say.

# "A SPRIG OF ACACIA."

SOUTH WALES has lost a distinguished worker in Bro. Dr. John Williams, S.W. Prince Llewellyn Lodge, who died on the 21st ult., at Cardiff. At a meeting of the Duke of York Lodge the same evening Bro. A. H. Parker I.P.M., who presided in the absence of the W.M. Bro. Joseph Stanfield, made sympathetic reference, before the commencement of business, to the death of Bro. Williams, whose brilliant career and genial personality he warmly extolled. He moved that a vote of condolence be sent to the Prince Llewellyn Lodge, with a request that the Duke of York Lodge should be included in the Masonic expression of sympathy extended to the widow. Bro. James Radley P.Prov.G.J.W. seconded, and the motion of condolence was carried in silence, the Brethren upstanding.

THE funeral of Bro. Gilbert Hastings Macdermott, the well-known music-hall singer, took place on the 14th ult., at Norwood. Immediately following the car was the deceased's private carriage, which contained many wreaths. The wreaths sent by relatives and friends were disposed over the top and down the sides of the hearse, the whole being surmounted by a broken pillar composed of primroses and narcissus. On the top was a floral dove, in the mouth of which was placed a card bearing the words, "From mother and the children." Most of the members of the Pimlico Lodge, of which the deceased was a member, attended, and when the coffin had been lowered they performed the usual Masonic ceremony of dropping a sprig of acacia into the grave of their departed Brother.

THE funeral of Bro. Stanley Leighton, M.P., took place at Oswestry Parish Church on the 9th ultimo, amid every manifestation of sympathetic respect. The body arrived from London at 3 o'clock, and was met by a representative assembly, including the mayor and corporation of the town, representatives of the county council and magistracy, the Provincial Grand Lodge of Freemasons, and deputations from various philanthropic, archæological, and political societies. The service was taken by the Bishops of Bangor and Shrewsbury, with whom were Archdeacon Thomas, Canons W. H. Fletcher and Trevor Owen, and Prebendary Moss headmaster of Shrewsbury School. The vicar, the Rev. Norman Ogilvy, an intimate friend of Bro. Stanley Leighton, who was with him when he died, was unable to take part owing to indisposition.

THE death of Bro. Colonel J. Randle Ford, of Bath, occurred on the 22nd ult., in his 84th year. Our late Brother was a P.M. of the Royal Sussex Lodge, No. 53 and a Past S.G. Warden of the Province of Somersetshire, and had the distinction of being the first volunteer enrolled in that county. He entered the army in March 1835 as an Ensign in the 95th (Derbyshire) Regiment, of which he subsequently became Adjutant. He left the Army after only ten years service, through ill-health contracted in Ceylon, but he was to the day of his death always regarded by the present officers of the 95th—now known as the Sherwood Foresters as the father of the regiment, and his wonderful memory was constantly applied to in matters concerning men who had belonged to it. One of the last public occasions at which Colonel Ford assisted was the proclamation of King Edward VII., and it is a remarkable fact that at the accession of Queen Victoria, as a subaltern, he carried the Queen's colours at the mounting of the guard at Dublin Castle.

# IN MEMORIAM. George William Speth.

THE passing away of such a notable Freemason as the late Secretary to the Quatuor Coronati Lodge, it has been thought, should not be exclusively recorded in the journals of the Craft; and that, in justice to his memory, some kind of notice, however brief and imperfect, of his really wonderful services to the Society he loved so well, ought to appear in the columns of the paper circulating in the neighbourhood of his abode.

Bro. Speth was best known as the Secretary of Quatuor Coronati Lodge, No. 2076, and editor of its "Transactions (Ars Quatuor Coronatorum)"; but there exists another Masonic Lodge with which he had even a longer connection,

the Unity, No. 183, his Mother Lodge, and the Secretaryship of which he held at the time of his decease. The Master of this Lodge, Brother J. Lloyd Bennett (who is a Bromley resident), has asked me to write a short memoir of our departed friend; and it is with a heavy heart and faltering

pen that I apply myself to the task.

A really adequate literary memorial of the late Brother Speth will, I trust, one day see the light, but at the present time of writing I can only claim to figure as the most unpretending of biographers, and shall ask the indulgence of all those who were intimately acquainted with the deceased, for the manner in which I am necessarily compelled to pass over in comparative silence many striking features of his remarkable career.

Bro. Speth, the son of German parents, was born in England in 1847. He early engaged in mercantile pursuits, and was a resident for some time in Cuba. After this he retired into private life, and in the year 1872 was initiated in the Unity Lodge, No. 183, London, of which he became the Worshipful Master in 1876. He was made a Royal Arch Mason in the Sir Francis Burdett Chapter, No. 1503, Twickenham, in 1883, and has since filled the three chairs of J., H., and M.E.Z.

His first contribution to Masonic literature was a history of his Mother Lodge, which appeared in 1881; but the period was now approaching when he would enter upon the congenial career of a Craft "littérateur," which he pursued with such undeviating success, until his sudden and lamented

death on the 19th inst.

The story of the formation of the Quatuor Coronati Lodge has been often told, but I must narrate it once more. Nearly twenty years ago the possibility of establishing a "Students Lodge" was seriously discussed by Bros. W. J. Hughan, G. W. Speth, W. H. Rylands, the Rev. A. F. A. Woodford and myself. Shortly afterwards the same idea occurred to Lieutenant-General Sir Charles Warren, K.C.B., and Bro. (now Sir) Walter Besant, and in the result the seven persons above named, with the additions of Lieutenant-Colonel S. C. Pratt and Bro. Paul Rylands, applied for a Warrant of Constitution, which was granted by H.R.H. the Prince of Wales, Grand Master, on 20th November 1884.

The Consecration of the Lodge, owing to the departure of the Master-designate, Sir Charles Warren, for active service in South Africa, was unavoidably postponed until 12th January 1886, when Sir Charles Warren was duly placed in the chair, and Bros. Sir Walter Besant and G. W. Speth invested as Treasurer and Secretary respectively. Sir Chas. Warren was elected for a second term, after which, as the laws of Masonry in this country do not allow the chair of a Lodge to be held for longer than two years in succession by the same Brother, the Office of Master passed to another member, who happened to be myself. But with regard to the Treasurer and Secretary, the duties they so happily undertook in 1886 were performed by them without intermission from that year, by Sir Walter Besant down to the present date, and by Bro. G. W. Speth until Friday last.

I must here pause to state that in the interval during which the Quatuor Coronati Lodge was in a state of "suspended animation," namely, between 1884 and 1886, Bro. Speth, besides being a constant contributor to the journals of the Craft, wrote a booklet of enduring value, called "Royal Freemasons," and rendered to myself great and never-to-beforgotten services in successive volumes of my "History of Freemasonry," an assistance that only came to an end with

the publication of the final volume in 1887.

Let me now return to the Quatuor Coronati Lodge which, as previously narrated, started on its mission—the association in Masonic fellowship of Craft students and the promotion of Masonic research—in January 1886. About a year afterwards it occurred to Bro. Speth that the "Transactions" of the Lodge would be comparatively useless unless they were printed and more widely read. This idea culminated in the formation of a Correspondence Circle, consisting of Lodges or Brethren who might care to each pay half-a-guinea yearly for the privilege of receiving the "Proceedings" of No. 2076 in printed form. The experiment was a bold one, but it has been crowned with the most signal success. The project was launched in February 1887, and at the present time close upon 3,000 "paying members" are actually enrolled in the Correspondence Circle. Nor does the number of new sub-

scribers show any sign of diminution. The cry still is "They come," and after making due allowance for deaths and withdrawals, the net increase of members per annum may be estimated at a good round figure. Thirteen volumes in all have been printed of the "Proceedings" or "Transactions," and a fourteenth is progressing, which will be published at the close of the year. There are also nine volumes of the close of the year. There are also nine volumes of "Archæologia," consisting either of rare manuscripts printed for the first time, or of reprints of previously published books and pamphlets of which few or any copies, besides those used (in each case) by the Lodge, are known to be in existence. The work, therefore, performed by Bro. Speth, as Secretary of the Lodge, and editor of its "Transactions," has been throughout of a very onerous character. Upwards of "two thousand nine hundred correspondents" in the Outer Circle alone, not to speak of the extensive "book-keeping" involved by the applications for the various commodities of the Lodge, nor of his multifarious duties in other directions, must have left the "managing director" of the Quatuor Coronati with very little spare time on his hands.

Bro. Speth was also a very diligent contributor to the columns under his control. A bibliography of his writings, even in the restricted area of "Ars Quatuor Coronatorum," would indeed carry me too far, but it may be stated that no subject was ever discussed in the "Transactions" of the Lodge, without its evoking an intelligent and graceful criticism from the editorial pen. The Degrees of Masonry; the derivation of "Free" in relation to Freemasonry; the Manuscript Constituons; and Cathedral (as distinguished from the other) Builders; were perhaps the topics dearest to his heart, and on all of them he wrote both learnedly and well, pouring out the treasures of his knowledge in a series of remarkable papers, the publication of which, in a collected form, is very greatly to be desired.

His latest pamphlet, a revised edition of "A Masonic Curriculum" for the use of Craft students, is characterised by a rare elegance of diction, and if affords me satisfaction to think that the very last letter I received from him was in acknowledgment of the compliment I had tendered in respect of the ability and power displayed in his most recent brochure, and of the beautiful language in which his remarks were

expressed.

Bro. Speth was a Past Assistant Grand Director of Ceremonies, in the hierarchy of the Grand Lodge, and a Fellow of the Royal Historical Society. In other and minor ways the honours of the Craft, as indicating the esteem in which he was held by the Brethren at large, fell thickly upon him. He was honorary member of many Lodges at home and abroad and of many Veteran Societies of Freemasons. On 17th November 1894 he was presented by his friends in the inner and outer circles of the Quatuor Coronati Lodge with a magnificent English chronometer, to which was appended a chain and jewel. The presentation was made by Sir Chas. Warren P.M., who after remarking that the work carried on by the Lodge was known far and near, went on to say, amid the approving cheers of the Brethren who were present, that the great structure of the Quatuor Coronati Lodge had been built up in a great measure by the admirable administrative skill and ability of Bro. Speth.

The subject of this memoir was not in robust health during a portion of 1900, but with the present year his friends were congratulating him on having been restored to his old form. Everything pointed to a protracted period of usefulness in the field of Masonic labour, which he had so thoroughly made his own. But it was not to be. On Friday last, with startling suddenness, the end came, and on Wednesday afternoon, the 24th inst., in the Bromley Cemetery, the remains of one of the best known and most widely-esteemed of English Freemasons, were laid at rest.—" Bromley and

District Times," 26th April 1901.

A STRIKING demonstration of respect for the memory of the late Bro. G. W. Speth was paid at a largely attended meeting of the "Correspondence Circle" of the Quatuor Coronati Lodge, held at Freemasons' Hall early last month. The wonderful industry and social virtues of the zealous Masonic antiquary were testified to from the Master's chair, the Secretary's table, and the lay Brethren's benches; and it added to the impressiveness of the various eulogisms delivered that one came from a Past Grand Master of Canada, and the historian of the Masonry of the Dominion.

This illustration of the universality of the Craft was added to by the fact that among the candidates for election to the Correspondence Circle, which was the special creation of Bro. Speth, were Brethren from Birmingham and Bengal, Warwickshire and Western Australia, Salop and New Zealand, North Wales and Natal, as well as from Manitoba and Michigan, New York and Victoria, Queensland and Fiji, Burma and the Argentine.
